

Whereas the over speed of different categories of motor vehicles on NH-353, SH, Market area has turned accident prone and hazardous to the lives and properties of general public .Keeping in view of the road safety of general public, in exercise of power conferred on me by sub section(2) of section 112 of motor vehicles Act,1988,I Dr.Poma Tudu,IAS,District Magistrate and Collector-Cum-Chairman,RTA,Nuapada do hereby restrict the maximum speed limit of different categories of motor vehicles as follows in respect of specified areas until further orders.


Sl no	Class of Vehicles	Maximum speed limit in KMs/Hr in SH & NH	School area	Market place and Town area
1	Motor Cycles	65	25	10
2	Light Motor Vehicles	80	20	10
3	Heavy motor Vehicles and all other vehicles	65	20	10
4	Auto Rickshaws	40	20	10

This restriction will come into force with immediate effect from issue of this notification.
