
ENGAGEMENT ORDER NO. 1791 /PLG-SS/18// DATE. 29.6.18 //

In pursuance to the Advertisement No.12511, dated 26.12.2016 & 9836, dated 01.12.2017 of OPEPA, Bhubaneswar and Resolution No.25605/SME, dated 26.12.2016, Letter No.25611/SME, dated 26.12.2016 & Corrigendum No. 23322/SME, dated 30.11.2017 of School and Mass Education deptt., Govt. of Odisha, the following selected candidates are hereby engaged as " Sikshya Sahayak (Junior Teacher Contractual)" in the school as mentioned against their name, under Nuapada District for a period as mentioned in the agreement on a fixed monthly honorarium of Rs.7,400/- (Rupees Seven Thousand Four Hundred) only subject to the following terms and condition :-


1. Teaching in the school shall be the main duty of the Sikshya Sahayaks (Junior Teacher Contractual).
2. They must maintain regularity and punctuality in attending school.
3. They must ensure completion of entire curriculum within the specified time.
4. They must assess the learning ability of each child and accordingly supplement additional instructions if any as required.
5. They must ensure minimum level of learning (MLL) for the students as prescribed by the Competent Authority (School & Mass Education Department).
6. They must ensure at least 90% attendance of the children in respective schools in all classes.
7. They shall reduce the dropout rate of the children in school below 10%.
8. They shall motivate the parents/guardians of the village in which Primary / Upper Primary School is situated for enrollment of children within the age group of 6 to 14 years. It shall be his/her duty to contact parents/ guardians in case children fail to attend classes regularly and get back such children to the classes.
9. They will hold regular meeting with parents and guardians and apprise them about the regularity in attendance, ability to learn, progress made in learning and any relevant information about the child.
10. They shall perform all such other duties as assigned to them by the competent authority as and when required.
11. They shall abide by the rationalization of teachers policy of Govt. as issued from time to time.
12. Whenever applicable they will work under the administrative control of Head Pandit / Head Master or Head Mistress in charge of the school to which he/she is assigned. They shall perform the duties as will be entrusted upon him/her by the concerned Head Pandit / Head Master or Head Mistress.
13. They may be assigned any other work in furtherance of the objective of the universalisation of Primary Education/RTE Act by Chief Executive Officer, Zilla Parishad, Nuapada or any other authority as decided by Government in School & Mass Education Department from time to time.
14. The engagement shall be cancelled, if any fraudulent testimonial is detected in future, if he/she is criminally proceeded against.
15. The Engagement Order issued is subject to the result of the WA No.442/17 filed by Banita Biswal and others and batch of writ appeals and W.P(C) No. 3471/18, 3681/18, 3682/18, 4297/18, 3677/18, 3679/18 and other cases.


1. Copy to persons concerned. Both the candidates are instructed to download the Engagement Order and join before Head Master/ Head Mistress of concerned school on or before 05.07.2018 under intimation to concerned BEO by submitting a copy of this Order, failing which the engagement shall be cancelled automatically. It is the duty of the concerned Sikshya Sahayaks (Junior Teacher Contractual) to submit his/her proposal for renewal of engagement yearly till completion of 06 years through concerned B.E.Os on completion of each year of engagement. (03 years for consideration as Junior Teacher and next 03 years as Assistant Teacher). And as per the instruction of the State Project Director, OPEPA, Bhubaneswar vide Letter No. 3117/MIS/2018, dated. 28.02.2018, they are also directed to fill up the Teachers Profile format after joining at respective schools and submit at Block Education Office concerned through HM/ CRCC for online updation within 3 days.
2. Copy to Head Master/ Head Mistress of concerned schools for information and necessary action. They are directed to intimate the reporting of the concerned Sikshya Sahayak (Junior Teacher Contractual) to BEO within two days.
3. Copy to Block Education Officer, Nuapada and ~~Khariar~~ for information and necessary action. They are directed to submit the joining reports of Sikshya Sahayak (Junior Teacher Contractual) to the DPC, RTE-SSA, Nuapada for compilation and onward transmission to OPEPA for updating the Sikshya Sahayak (Junior Teacher Contractual) applicant data and also to complete the updation of Teachers Profile data of the newly joined Sikshya Sahayaks (Junior Teacher Contractual) within 7 days.
