





Recruitment of Medical Officers on contractual basis as per the Odisha Medical & Health Services Cadre under H&FW. Department .

1. Applications are invited from prospective candidates through the proforma at ANNEXURE-1 . The post contractual in nature.
2. The Age of the applicant should be Maximum 68 (Sixty Eight) years for applying for the post subject to their physical fitness.
The date of birth entered in the High School certificate or equivalent certificate issued by the concerned Board/Council will only be accepted.
3. Educational qualification
 - a. The candidate must have possessed M.B.B.S. or equivalent degree from a Medical College or Medical Institution recognized by Medical Council of India.
 - b. The candidate must have valid registration certificate under the Odisha Medical Registration Rule 1965.
 - c. The candidate must have possessed required conversion certificates recognized by Medical Council of India (MCI) in case of candidate having degree from University Foreign.
4. Method of selection
 - a. The Walk-in-interview /counseling will be held in all working days from 1st day to 15 day of every month .The candidates need to register themselves between 10.30 A.M. to 12.30 P.M. on the date of interview/counseling.
 - b. The candidate who will register first his/her interview serial number will come first. Accordingly, the list of candidates will be prepared in chronologically order of registration.
5. The consolidated monthly remuneration of the Doctors engaged on contractual basis against the vacant post of Assistant Surgeons/Specialists in different institutions will be paid as per Resolution No.17390/H&FW. Dated 29.06.2018 Govt. of Odisha H&FW. Deptt. as follows
Assistant Surgeon - Rs 55000/P.M. with a hike of 3% in every year on satisfactory completion of one year of service.
Specialist- Rs 60000/- P.M. with a hike of 3% in every year on satisfactory completion of one year of service
6. Certificate and documents to be carried to the interview
The candidate Original & Photocopies (1 set) of the following documents
 - a. +2(Intermediate/Higher Secondary Examination Certificate issued by the concerned Board/Council
 - b. M.B.B.S. degree certificate and Post Graduation certificate issued by the recognized University
 - c. If the candidate claims to possess qualification equivalent to the prescribed qualification, the rule/authority (with number and date) under which it is so treated must be furnished.
 - d. H.S.C. or equivalent certificate in support of declaration of age issued by concerned Board/council.
 - e. Identify proof
 - f. Medical registration certificate under Odisha State.
 - g. Other registration if any
 - h. One recent passport size photograph(unsigned and unattested)
Note: If a candidate fails to furnish any of the Original certificates and documents in respect of photocopies submitted with the application by him or her for verification on the day of interview, then his/her candidature will be rejected.
7. The appointment letter will be issued to the selected candidate on the same day.
 - i. The selected Doctors need to join in their place posting positively within 15 days of issue of appointment letter.
