### OFFICE ORDER

In pursuance of Govt. in PR & DW Deptt. Letter No. 6681 / Dtd. 06.04.2018, Advertisement inviting applications for selection and engagement of 72 Nos of Gram Rozgar Sevaks in Nuapada district was published vide L. No. 2086 / Dtd. 20.08.2019. Accordingly certificate verification of 72 nos. of eligible candidates was conducted by District Level Committee on 04.02.2020.

**AGREEMENT**

THIS AGREEMENT IS made on this ..... **Day of Month of February Year of 2020** BETWEEN Collector-cum-CEO, Zilla Parishad, Nuapada (here in after called the First Party) OF THE ONE Part AND ..... aged about ..... years residing At- ..... PO- .....G.P. - .....Block- ..... Dist- **Nuapada** (here in after called the Second Party) of the other part.

Whereas the Second Party is engaged to perform the duty of Gram Rozgar Sevak in the Gram Panchayat ..... **Block** ..... under Panchayati Raj Department, Government of Odisha.

And whereas the First Party desires to engage the Second Party on contract basis as Gram Rozgar Sevak for the period specified hereunder and the Second Party has agreed to enter into this contract and abide by the terms and conditions of this agreement.

NOW THIS AGREEMENT WITNESSES and the parties here under hereby agreed as follows.

1. That the First Party shall provide engagement to the Second Party in Nuapada District and engaged him initially to **GP** ..... for a period of one year commencing on ..... **Day of Month of February Year of 2020** and ending on ..... **Day of Month of February Year of 2021**. As agreed to by both the parties and the contract of this engagement ipso-facto shall be terminated on completion of the date specified for which no formal notice or order is required to be issued by the First Party. The contract will stand rescinded on expiry of the period.
2. That the Second Party shall submit himself/herself to the orders of the First party and shall at all times, obey the rules prescribed and shall discharge, whenever required, such duties as may be assigned.
3. That the Second Party shall employ himself/herself efficiently and diligently and to the best of his/her ability.
4. That the Second Party shall be paid Rs.7,000/- (Rupees Seven thousand) only per month as consolidated remuneration.
5. The Second Party shall not claim the service benefits as admissible to the State Government employee.
6. That the Second party shall not be eligible to get any other allowances and shall not claim any other dues except the remuneration as mentioned in Clause-4 above.
7. He/She shall handle hardware, software and other equipments/accessories, registers and documents in a transparent manner and make over the charge of the same to the authorized person after termination /relief from the present engagement.
8. That the second party shall be eligible subject to exigency of public service for casual leave of 10 days during calendar year, but such leave shall be subject to the prior permission of the First party of Officer duly authorized by him in writing.
9. That the Second Party shall not be entitled for any other kind of authorized absence beyond authorized leave. If she/he remains absent with permission and he/ she does not have any authorized leave at his/her credit or she/he remains on leave without prior permission, the proportionate amount from his/her consolidated remuneration shall be deducted.
10. That breach of any of the terms of conditions of this agreement by the Second Party shall be treated as misconduct.
11. That the second party has agreed to serve in the manner as required and perform the duties as assigned by the First Party and she/he has agreed to be disengaged without any notice on the ground of misconduct even during the operation of this agreement.
12. The second party shall maintain the Official secrecy of the works done by him/her.
13. Gram Rozgar Sevak is a "District Cadre" post and is transferable in nature within the concerned District. The Collector-cum-CEO, Zilla Parishad is competent to transfer the GRS from one Gram Panchayat to another Gram Panchayat within the District in view of exigencies of public service or in consideration of genuine grievance or on administrative ground.

IT IS EXPRESSLY STATED AND AGREED that any duties rendered under this agreement by the Second Party shall not under any circumstances whatsoever confer him/her any right to claim for any scale of pay or to be appointed in any Government Office that may exist now or may arise in future.
