ORDER

Whereas in exercise of the powers conferred under Section 10(2)(l) of the Disaster Management Act 2005, National Executive Committee vide Ministry of Home Affairs, Govt. of India Order No:40-3/2020-DM-I(A) dated 29.7.2020 has directed extension of the Lockdown in Containment Zone up to 31.8.2020 and to re-open prohibited activities in a calibrated manner in areas outside Containment Zones;

And Whereas the Government of Odisha, vide Order No.4852/ R&DM(DM) date 31.7.2020 has promulgated guidelines in the State of Odisha effective from 1.8.2020 until the midnight of 31.8.2020 by extending the Lockdown in all COVID-19 Containment Zones as well as regulation of activities in areas outside the containment zone with stipulations contained therein.

And as per the Clause -12 of the aforesaid order, District Collectors are authorized to impose area specific reasonable restrictions as deemed fit for containment the spread of COVID-19.

And whereas it has come to the notice of District Administration that Covid-19 positive cases found in and around Nuapada NAC.


And whereas there is prohibition of Large Public gatherings/Congregations under clause-10 (e) of the aforesaid order, it is necessary to impose area specific restrictions in those places for containment the spread of COVID-19.

**Now therefore, I Smt. Madhusmita Sahoo, IAS, Collector & District Magistrate, Nuapada do hereby impose SHUTDOWN on the entire area of Nuapada NAC & Khariar-Road NAC for two days i.e. 8.8.2020 and 9.8.2020 with relaxation from 6.00 AM to 11.00 AM.**

The Exe.Officers of NACs shall arrange wide publicity of the order through loudspeaker/Public Address system.

The restriction shall not apply to:

- District Administration/ Police/ Govt. officials on duty.
- Doctors, Medical/Paramedical staff( Govt. & Private)
- Staff of IT and ITeS Companies on production of their ID cards
- Any Person, in case of medical or other emergency.
- Owner/Staff of Chemist Shops
- All Industrial Units
- All Construction activities.
- Movement of Public transport, private vehicles and taxis to & from airports, Railway stations and bus terminals/Stand/Stops, for facilitating movement of passengers by air, rail and road.
- Operation of hotels and hospitality units, including their associated offices, movement of staff and associated personnel.
- Dhabas along National and State Highways/Major roads for takeaway only.
- Petrol Pumps and CNG Stations
- Print and Electronic Media identified by District Police.
- Agricultural, Horticulture operations.
