





Terms & Conditions

1. After acceptance of the bid of the firms/suppliers the approved bidder shall have to execute an agreement with the Block Development Officer, Nuapada within three days.
2. The approximately expenditure of sports Equipment is Rs.600000/-
3. The selection of Bidder to supply the items is the sole discretion of the purchase committee. The sample produced by the bidder at the time of opening of bid shall be examined by the committee at first and the rate of the item shall be considered from the selected items only.
4. The bidder have to be deposited security of Rs.6000/- (Rupees six thousand only in shape of Bank Draft in favour of Block Development Officer, Nuapada while filling bid forms. Bid filled without EMD and tender paper cost shall be rejected.
5. The payment of bills will be made as per the approved rate incorporated in the agreement.
6. The supply of items to be executed within 15 (Fifteen) days of receipt of supply order. In case the suppliers fail to supply required items within time specified or fail to adhere to the term and condition of this agreement or the supplied article found below the standard approved by the purchase committee the contract shall be terminated and the EMD/security deposited shall be forfeited.
7. In case of any complaint regarding the supplied items, than the suppliers shall replace the same at his own cost. The decision of Block Development Officer, Nuapada shall binding and final.
8. The suppliers shall be responsible for any loss/damage during transit up to Delivery Points.
9. Block Development Officer, Nuapada reserves the right to reject any or all the bid received without assigning any reason thereof.
10. No request for enhancement of approved rate shall be entertained for the period once the agreement is signed.
11. Block Development Officer, Nuapada may terminate the contract any point of time for violation term and condition of agreement without notice or any of document produced by the suppliers is found forged/fabricated/unauthentic at later stage.
12. The order is liable to be cancelled at any time by providing 15 days notice in case of any problems arises.
13. The decision of the purchase committee is binding and final in selection of articles/brand.
14. The supply order will be placed as per the brand and rate quoted by the bidders and also availability of funds.
15. The bidder shall come with & exhibit samples of item to be supplied in conformity with the specification (mentioned in the bid document) on the bid-opening day.
16. Tender document must be submitted along with all the relevant documents. This is required to show that the bidder had accepted all the terms and conditions mentioned in this tender document.
17. Delivery Mechanism:-
The delivery of the items as per the list of each location shall be made by the bidder at the respective place. Random quality verification will be conducted at the time of each delivery. If the quality and/or quantity is found to be non-satisfactory, Bidder will be penalized up to 100% of the Order value.
18. Validity of Tender :- 30(thirty) days from date of receipt of Bid documents.
19. Settlement of Dispute:-
In case of any dispute arises between the supplier and purchaser shall be tried to resolved amicably by mutual understanding. If the parties failed to resolve the dispute within 21 days shall be settled through arbitration under the jurisdiction of Nuapada Court only as per Indian Arbitration and Conciliation Act-1996.
20. Bid Price:-
The transportation & Installation charges are also to be included in the Bid Price.
All taxes, duties and other levies payable by the dealer under the contract shall be included in the Bid Price.
The rates quoted by the bidder shall be fixed for the duration of the contract and shall not be subject to adjustment on any account.
21. Payment:-
Payment shall be made after random inspection of supplied materials by the Inspection team and if found satisfactory.
