1. The Collector & District Magistrate, Nuapada-Cum-Chairman, R.M.C. Khariar Road invites Percentage Rate bids in **Single cover system** in online mode for the construction of works as detailed in the table, from the class of eligible contractors as mentioned in column – 7 (Seven ) registered with the State Governments and contractors of equivalent Grade / Class Registered with Central Government / MES/ Railway/CPWD for execution of civil works. The proof of registration from the appropriate authority shall be enclosed along with the Bid. If successful, the bidder who has not registered under State Government has to register under the appropriate registering authority of the State Government of Odisha in appropriate class of eligibility before award of the work.
2. The bidders may submit bids for the following works.

The Tender Paper cost and Earnest Money Deposit / Bid security of the amount specified for the work, the bidder shall make electronic payment using his / her Internet Banking enabled account with designated Bank or their aggregator Bank such as SBI / ICICI / HDFC or the bidder having account in other bank can make payment using NEFT / RTGS facilities of designated banks. Bidders desirous to hire machineries or equipments from outside the State or owned but deployed outside the state are required to furnish 2 % of the amount put to tender as Bid security.
5. The Bid documents will be available in the website: [www.tendersorissa.gov.in](http://www.tendersorissa.gov.in) from **10.00 AM of 04.01.2022 to 10.01.2022 5.30 PM for online bidding.**
6. The bidder must possess compatible Digital Signature Certificate (DSC) of Class-II or Class-III
7. Bids shall be received only "on line" on or before **10.01.2022 up to 5.30 PM.**
8. Bids received on line shall be **OPENED** at **11.00 AM** on **11.01.2022** in the **OFFICE OF THE REGULATED MARKET COMMITTEE, KHARIAR ROAD**, in the presence of the bidders who wish to attend. Bidders who participated in the bid can witness the opening of bids after logging on to the site through their DSC. If the office happens to be closed on the last date of

opening of the bids as specified, the bids will be opened on the next working day at the same time and venue.

9. The original affidavit regarding authentication of the documents and all other documents in original shall be furnished before the TEC at the time of Opening of Tender for verification.
10. The cost of bid documents as mentioned in Column 6, the bidder shall make electronic payment using his / her Internet Banking enabled account with designated Bank or their aggregator Banks such as SBI / ICICI / HDFC or the bidder having account in other Bank can make payment using NEFT / RTGS facilities of designated Banks .
11. The Engineer contractor willing to avail the Exemption of EMD will submit scan copy of the affidavit to avail the exemption along with bid document and original affidavit will be submitted before opening of technical/Financial Bid. Affidavit should contain how many times such facilities have been availed by him prior to this during the current financial year. Otherwise they will not be entitled to avail such facilities.
12. The SC/ST contractors willing to avail the facilities as fixed by Govt. will submit an affidavit for the same along with tender document; otherwise they will not be entitled to avail such facilities. Claim at the time of opening of tender or later will not be entertained.
13. Special Clause: If the rate quoted by the bidder is less than the estimate cost put to tender, then the successful bidder shall have to furnish the exact amount of differential cost i.e estimated cost put to tender minus the quoted amount as Additional Performance Security within five days of opening tender in shape of Demand Draft/Fixed deposit receipt/N.S.C/K.V.P drawn in any nationalized bank in favour of the Secretary, RMC Khariar road
14. The authority will not be responsible for any technical snag or network failure during on-line bidding.

16. The authority will not be held responsible for any technical snag or network failure during on-line bidding.
17. The authority reserves the right to cancel any or all bids without assigning any reason.




