

SHORT QUOTATION CALL NOTICE

Sealed quotations are invited for "**Sale of E-Waste collected in Wealth Centers of NAC Khariar Road**" to the intending (buyers) authorized E-waste collection agencies /dismantler centers (dismantler / PROs / firms /suppliers /dealers /NGOs) registered with CPCB / OSPCB. The E-waste collected from different wards of NAC Khariar Road is stored / stacked in Material Recovery Facilities (MRFs) of Khariar Road. The lists of MRFs are under Appendix 1 (a) of this document. The bidder shall quote the buying price (lot basis per MRF) of the E-waste already collected and stacked in MRFs. The bidder must submit the application along with the financial proposal on or before 20.06.2022 at 11.00 am through by hand / postal / courier. Applications received after due date and time shall be summarily rejected and Office of NAC Khariar Road is not responsible for any delay of postal / courier delivery. The received applications shall be opened on 20.06.2022 at 11.30 am in the office chamber of Executive Officer NAC Khariar Road.

1. Documents accompanying the bid document:

- The bidder must submit the Application form (Annexure-1) along with all the relevant documents.
- Authorized E-waste collection authorization document issued by OSPCB / CPCB
- Bidder Information document in Annexure-4
- GST Registration Certificate
- Financial Proposal, Annexure-2 and Annexure-3
- Security Deposit (SD) in the form of Demand Draft of Rs.10,000/- (Rupees Ten thousand) only in favour of Executive Officer, NAC Khariar Road payable at Khariar Road (Any proposal found without the Demand draft of Rs. 10,000/- shall be out rightly rejected).
- The ISD of the unsuccessful bidders shall be returned.
- The ISD of the successful bidder shall be returned after 1 year.

2. Terms and Conditions:

- The lifting of E-Waste from the Wealth Centers by the selected bidders shall be within 7 days from the date of issuance of Sales Order to the selected bidder.
- The bidders are expected to quote their best rates per lot.
- Initial Security Deposit will be paid after One Year

- If the successful bidder not lift the waste after 7 days of work order issue than he/She will be penalty Rs 100 per Quintal and it will be deduct form security deposit. And also contract will terminate with price notice and report to SPCB in this regards.
- The sealed quotation should reach the following address:
- In case of any discrepancy between price quoted in figures and words the price quoted in words shall be considered.
- The bidder shall deposit the amount and lift the E-waste form MRF within 10 days from the date of receipt of the order of lifting.
