

2. The tenderer has to attach EMD Rs.5000.00 in shape of demand draft in favour of the Divisional Forest Officer, Sunabeda Wildlife Division, Nuapada along with the tender, otherwise their bid shall not be qualified for the tender. The EMD shall be refunded to unsuccessful tenderer.
3. The price quote should be inclusive of all taxes, transportation and deliveries at Range head quarter under Sunabeda Wildlife Division, Nuapada.
4. The tenderer or his authorized representative shall produce a sample packet of their materials in advance or same day before the tender selection committee for inspection and test.
5. The stock should be delivered in good condition within 07 days from the date of issue of purchase order with Challan/ credit bill along with bank account information. No advance payment will be made.
6. The material should be delivered on the site after sampling at Division Office and proper weighing in presence of the Forest Range Officer in-Charge of the Range & taking counter signature on challan copy.
7. All materials should be supplied as per the sample given and selection thereof, failing which the supply orders will be cancelled automatically.
8. The rate of successful bidder may be valid up to till next call/tender call.
9. The Tender will be finalized by the Purchase Committee of the Division taking into consideration the price quoted and quality of the product.
10. The undersigned reserves the right to reject/cancel any or all the quotation without assigning any reason thereof and terminate the order in case of changes in the Government procedure or policy or instruction/direction.
11. If any company is black listed by any State Government department or agency, such tenderer is liable for rejection at any time during the validity of the tender and supplies will be terminated.
