1. The quotation received incomplete or after the scheduled date and time are liable to be rejected.
2. The tenderer has to attach EMD Rs.5000.00 in shape of demand draft in favour of the Divisional Forest Officer, Sunabeda Wildlife Division, Nuapada along with the tender, otherwise their bid shall not be qualified for the tender. The EMD shall be refunded to unsuccessful tenderer.
3. The price quote should be inclusive of all taxes, transportation, deliveries & installation of sites of the Nuapada & Komna WL Range of Sunabeda Wildlife Division, Nuapada.
4. The bids should contain the price bid clearly mentioning the rate per unit in figure and words in neat. Any variation between the rate in figure & words, the rate in words will be taken in the consideration.
5. The tenderer or his authorized representative shall produce a sample of the Solar street light in advance or same day before the tender selection committee for inspection and test.
6. The stock should be delivered in good condition within 07 days from the date of issue of purchase order with Challan/ credit bill along with bank account information. No advance payment will be made.
7. The material should be delivered on the site after sampling at Division Office and Presence of the Range Officer and taking counter signature on challan copy.
8. All materials should be supplied as per the sample given and selection thereof, failing which the supply orders will be cancelled automatically.
9. The material should be specify in the bids the Battery type, Driver Circuit, Watt street light, capacity & pole size.
10. The rate of successful bidder may be valid up to till next call/tender call.
11. The Tender will be finalized by the Purchase Committee of the Division taking into consideration the price quoted and quality of the product.
12. The undersigned reserves the right to reject/cancel any or all the quotation without assigning any reason thereof and terminate the order in case of changes in the Government procedure or policy or instruction/direction.
