

The proof of registration from the appropriate authority shall be enclosed along with the Bid. If successful, the bidder who has not registered under state government has to register under the state PWD in appropriate class of eligibility before signing of the agreement. The bidders may submit bids for the following work.

Bids shall be received by this office up to 5.00 PM on date =20.10.2022 through Registered Post / Speed Post only. The authority will not be held responsible for any Postal delay in delivering of the Bid documents or non-receipt of the same.
3. The Bid will be opened on Dt =02.11.2022 at 11.30 A.M. in the office of the undersigned in the presence of the bidders or their authorized representative.
4. Bid documents can be purchased from this office on payment of the tender cost in shape of cash or DD drawn in favour of **Block Development Officer, Khariar** payable at SBI Kharir . **This is non-refundable.**
5. The tender documents can be downloaded from <http://nuapada.nic.in> on payment of appropriate tender cost Rs.3,000.00 in shape of Demand Draft in favours of **Block Development Officer, Khariar** and submit the DD in a separate envelope marked "COST OF TENDER DOCUMENT DOWNLOADED FROM INTERNET" along with the tender.
6. Bidders shall submit original affidavit regarding authenticity of their documents along with their bids. Bids shall be accompanied with attested true copy of valid registration certificate, valid VAT clearance certificate and PAN card.
7. The affidavit should clearly speak regarding the name of work for which the tender is submitted. One should mention clearly in the affidavit to avail price preference in case of SC/ST category if any.
8. Engineer Contractor seeking exemption of E.M.D. is required to submit an affidavit to the effect that he has not yet availed the facility for more than two works during the current financial year.
9. **Additional performance security shall be deposited by the bidder when the bid amount is less than the estimated cost put to tender. In such an event, only the successful bidders who have quoted less bid price/rates than the estimated cost put to tender shall have to furnish the exact amount of differential cost i.e. estimated cost put to tender minus the quoted amount as APS in shape of Demand Draft / Term Deposit Receipt pledged in favor of Block Development Officer, Khariar** Other details can be seen from DTCN.
10. If stipulation arises, tender will be decided through a transparent lottery system on dated=02.11.2022 at 1.00 P.M.
11. The authority reserves right to reject any or all the bids without assigning any reason thereof.
12. The SGST & CGST of Cement and MS Rod will be deducted from the bill as it is included in the analysis of rate.
