1. The Bid documents will also be available in the district website <http://nuapada.nic.in>
2. The tender documents consisting of plans, specifications, schedule of quantity and the set of terms & conditions of the contract will be made available for sale in the office of the **undersigned** to the contractors or to their authorized agents on payment of cost of tender paper (Non-refundable) in cash as mentioned at Col. No. 4 above.
3. The tender document must be accompanied with photo copies of valid Contractor's Registration Certificate (CDMS), valid ITCC (PAN Card), GSTIN registration Certificate, Bid Security Declaration. However, all the tenderers are required to furnish an affidavit duly sworn in before Executive Magistrate / Notary at the time of submission of tender papers about the authenticity of tender documents, failing which the tender will be rejected. Besides that, the tenderers also have sworn in the affidavit that, "I / We hereby confirm and declare that, if I / We will withdraw or modify the bid during the period of validity, I / We will be suspended for a period specified in the tender documents in the effect of **"Bid Security Declaration"**
4. **BID SECURITY / EARNEST MONEY DEPOSIT (EMD)** As per Office Memorandum No. 07556900052021(Pt)4710/W, dated 12.04.2022 of Works Dept. Govt. of Odisha on account of slowdown in economy due to the pandemic; there is acute financial crunch among vendors. This in turn is effecting timely execution of contracts. It also been represented that this may affect the ability of vendors to bid in tenders and hence reduce competition. Besides, Govt. of India have made provision in Rule-171 of General Financial Rule, 2017 asking the bidders for executing a **"Bid Security Declaration"** in lieu of Bid Security with stipulation that if they withdraw or modify their bid during period of validity etc. they will be suspended for the time specific in tender documents. Considering the difficulties faced by the vendors and to facilitate competition in wake of slow down of economy due to COVID-19 pandemic. The State Govt. also has decided that no provisions regarding Bid Security should be kept in the Bid Documents and only provision for **"Bid Security Declaration"** should be kept. Further, whenever, there are compelling circumstances to ask for Bid Security, the same should be done only with the approval of the next higher authority to the authority competent to finalize the tender. The above instructions will be applicable for all tenders issued till 02.11.2022.
5. The sale of tender paper will be available during office hour from **10.30 A.M. of dt. 31.10.2022** up to **4.00 P.M. of dt. 14.11.2022** & the tender papers will be received from **10.30 A.M. of dt.31.10.2022** up to **4.00 P.M. of 15.11.2022** and the same will be opened on date. **Dt.16.11.2022** at **11.00AM.** in the Office of the **under signed** in the presence of the tenderers or their authorized agents who wish to be present. If the Office happens to be closed on the date of receipt and opening of the tenders as specified, the same will be received and opened on the next working day at the same time and venue.
5. **Additional performance security in case of Abnormally Low Bids (ALBs)** Additional performance security shall be obtained from the bidder, when the bid amount is less than the estimated cost put to tender. In such an event, only the successful bidder who has quoted less bid price/rates than the estimated cost put to tender shall have to furnish in the following manner as per Office Memorandum No. 4559 dated 05.04.2021 of Works Dept. Govt. of Odisha.

7. The applicable Additional Performance Security (APS) shall have to be furnished by the successful bidder in shape of Term Deposit Receipt duly pledged in favour of the Block Development Officer, Nuapada / Bank Guarantee in favour of the Block Development Officer, Nuapada from any Nationalized/Scheduled Bank in India within seven days of issue of Letter of Acceptance (LoA) by the Block Development Officer, Nuapada to the successful bidder otherwise the bid of the successful bidder shall be cancelled and the EMD/Bid Security shall be forfeited. Further proceeding for blacklisting shall be initiated against the bidder. (As per Works Department Office Memorandum No.14459/W, Dated 20.09.2018).

8. Bid document can be downloaded from the Official website of Govt. of Odisha (<http://www.nuapada.nic.in>). The bidders, who downloaded the bid document from the internet site will have to pay the cost of the tender documents as indicated in column 4 (Four) of the above table in shape of demand draft drawn from any nationalized scheduled bank in favour of the Block Development Officer, Nuapada and payable at Nuapada in separate envelope marked "Cost of bid document downloaded from Internet" along with bid documents. Authority will not be held responsible, if any portion of the bid document is excluded or modified in the downloaded bid document.

9. Bids must be delivered in sealed cover super scribing the name of the work having mentioned as Tender Call Notice No. 6447 /2022-23 dtd. 29.10.2022. in the Office of the Panchayat Samiti, Nuapada. Bids shall be received in the Office of the under signed by Registered post / Speed post only. The authority will not be held responsible for postal delay in the delivery of the documents or non-received of the same by 4.00 PM of date 15.11.2022.

10. In case of SC/ST bidder who wants to avail the price preference he must have to furnish the required affidavit to avail price preference.

11. The bid must be accompanied with the "Bid Security Declaration" instead of EMD / Bid Security, in the standard format i.e Annexure-I as provided in the Bid document.

12. The Bidder must go through the Bid documents meticulously before dropping in the tender box.

13. Bid value should be exclusive of GST. GST on works Contract as applicable shall be paid at the time of Payment over and above the Gross amount of the Bill as per Odisha GST Act 2017.

14. The contractor has to quote the percentage excess or less up to two digits only after decimal point. If he quotes the percentage excess or less in more than two digits after decimal point, the first two digits after decimal point shall only be considered without rounding up.

15. In the eventually of failure on the part of lowest successful bidder to produce the original documents, he/she shall be debarred in future from participating in tender for three years and necessary action will be taken for black listing of contractor.

16. The Block Development Officer, Nuapada reserves the right to reject any or all the tender without assigning any reason thereof.
