

If failed to supply in the stipulated time, the order may liable to be cancelled.
7. The Bidder will deposit @2% of the cost of the items indicated against each as refundable security money (to unsuccessful bidder) through DD drawn in favour of Chief District Veterinary Officer, Nuapada payable at Nuapada along with Quotation paper.
8. The Quotation should produce the sample of the material before the committee during opening of Quotation.
9. The Quotationer should furnish the GSTIN clearance certificate and ID proof along with the Quotation.

11. The undersigned reserves all right to cancel any or all Quotations at any time without assigning any reason thereof.


