6. The bidder must possess a compatible Digital Signature Certificate (DSC) of Class-II & Class-III.
7. Bid shall be received only online on or before dated 18.11.2022 up to 5.00 P.M.
8. Bids received online shall be opened at 11.00 A.M. dated 19.11.2022 in the Office of the Divisional Forest Officer, Khariar Division in presence of the bidders who wish to attend. Bidders who participate in the bid can witness the opening of bids after logging to the site through their DSC. If the office happens to be closed on the last date of sale on receipt of the bids as specified, the bids will be opened on the next working day at the same time and venue.
9. The bidder shall deposit the cost of the bid document as mentioned in column No. 5 in shape of Demand draft drawn in favour of the "Divisional Forest Officer, Khariar Division," payable at Khariar.
10. The bidder shall have to furnish a security declaration as per the Office memorandum No. 8943 dated 18.03.2021 of Finance Department, Government of Odisha in lieu of the bid security in the format annexed, form of bid security declaration along with the bid.
11. Additional performance security has to be deposited by the bidder if the bid amount is less than the estimated cost as per amendment to Para 3.5.5 (V) of OPWD code Vol. I modified the Vide Work Department office memorandum No.4559 dated.05.04.2021 as given in DTCN.


