


**Criteria for selection of WSHG:-**

- 1) WSHG for this purpose intervention include SHG Federation.
- 2) WSHG must have completed 2 years from the Date of Formation.
- 3) WSHG should belong in respective village areas.
- 4) WSHG must have an active saving Bank Account.
- 5) WSHG must have availed Bank loan & not be a Bank loan defaulter.
- 6) WSHG must have undertaken regular & systematic Book keeping including maintenance of meeting register, cash book, updated pass book among others.

The Dist. level committee will scrutinize the EOIs based on the SHG selection criteria & select the empanel list of SHGs.

With kind reference to above it is to inform that, we have provided 2 nos Bio Flock units at Bhainsatal & 1 no at Baloda.

Now we are planning to provide 3 more Bio Flock units of 2 tanks( 15000 Lt each) each unit in 3 of the balance 6 no villages namely Budhipalli, Jangula, Amlidadar, Palsabhadar, Bhusudi & Parkod.

The cost of each unit will be around Rs 2,07,000/- out of which the SHG may have to contribute Rs 20,000/- as beneficiary share.
