**SHORT QUOTATION CALL NOTICE**

Sealed quotations in plain paper are invited from the authorised dealers /distributers /Supplier for supply of need based medicines for field institutions to manage in the case of eventualities of lumpy skin disease in Nuapada District. The list of all items with detail specification, eligibility criteria and Quotation term and condition are annexed herewith. The sealed Quotation will be received by speed post or by hand only on or before dt-19.12.2022 at 3 PM. and the Quotation will be opened on dt-20.12.2022 at 11 AM. in presence of bidders or their authorized representatives in the O/o CDVO, Nuapada. The absence of any of the bidders or their representatives will not be a bar to open the quotations received. The quotation received incomplete and after scheduled date and time shall be rejected. Rates should be quoted for each items including GST and other taxes and the items are to be delivered at O/o CDVO, Nuapada, The undersigned reserves right to reject any or all quotations without assigning any reason thereof. All legal disputes if any relating to the quotation are subject to jurisdiction of court of law of Nuapada district.

**PREQUALIFICATION FOR QUOTATION:**

1. The participating bidder should be an authorised Dealer/Distributor/Supplier having valid drug licence & GST registration.
2. The participating bidder who has been blacklisted by the State Govt. /Central govt. /any PSU is not eligible to participate in this procurement process through quotation.
3. Agencies/bidders of Odisha state only are allowed for bidding.

**TERMS AND CONDITIONS OF QUOTATION:**

1. The quotation should be neatly type written without any correction/overwriting & each page of quotation paper should be numbered.
2. Supply should be made at the O/o-CDVO, Nuapada within 07 days of receiving supply order.
3. The bidder should have a valid drug licence.
4. The bidder should have valid GST registration certificate of Odisha state.
5. The bidder should enclose self-attested copy of PAN, copy of valid drug licence, GST Registration certificate and GST clearance for last quarter.
6. The bidder can submit their quotation for individual or multiple items intend to supply from the list of medicines mentioned below inclusive of all taxes
7. The tax will be charged as per Govt. guideline.
8. The Payment shall be made after delivery of items in proper condition and as per specification through RTGS after submission of bills/vouchers. The bank details of the bidders should be mentioned on the body of bill.
9. Medicines supplied shall not have expiry date less than one year.
10. The rate contract once approved should remain valid for one year from the date of approval.
11. The bidder should give a self-declaration in his office letter pad that he has not been blacklisted by the State Govt. /Central govt. /any PSU.
