2. The required item should be delivered at the NAC, Nuapada.
3. The tenders have to deposit an amount of Rs.5000 (Rupees Five Thousand) Only towards E.M.D./ security in shape of Bank TDR duly pledged in favour of the Executive Officer, NAC, Nuapada along with the tender failing which the tender will be rejected out rightly.
4. The successful tenderer should supply the Bicycle within 15 days from the date of received of supply order to NAC, Nuapada. If the tenderer fails to supply the Bi-cycle within the specified date, the order would stand automatically cancelled and the EMD/ security will be forfeited.
5. The sealed tenders in plain papers in the proforma should accompany along with the self-attested photocopies of the following documents:
  - i) PAN Card
  - ii) GST Registration certificate
  - iii) Registration Certificate of the firm from the competent authority if any.
  - iv) Any document showing previous experience in the specific field.
  - v) Any other relevant document lawfully required by the Committee.
  - vi) (The original certificates shall be produced at the time of execution of an agreement for supply of the materials.)
