TERMS AND CONDITIONS

- 1 The department /office hiring the mobile van (COMMANDER/TATA 407/TATA MAGIC/BOLERO with Stand) for repair maintenance tube well for one year. The office is not responsible for any damage / loss caused /injury or any accident made to any person or damage to any property on account of her/his vehicle any manner whatsoever.
- 2 The hire charges to be paid for monthly basis which is quoted price approved rate by the BDO (excluding Fuel)
- 3 The vehicle towards repair, replacement of spare parts, lubricant, oil of engine & driver charge will be borne by the bidder or owner of the mobile vehicle.
- 4 The driver and vehicle must have a valid driving licence for driving light transport passenger vehicle.
- 5 The vehicle must achieve a fuel efficiency of 10KM per litre.
- 6 A logbook shall be maintained by the driver in proper way & the detail of the make and year of manufacture of the vehicle, registration no, mileage (Kms covered per litter) and name of the driver with driving Licence No and period of validity should be specifically provide in the general bid information to be furnished with the Quotation / Tender.
