
#### TERMS & CONDITIONS:

1. The vehicle should not be more than 03 years old) from its purchase from the showroom and it should be Taxi Vehicle only.
2. The engine and body of the vehicle should be in good condition.
3. The last date of the quotation will be up to 1.00 P.M on dtd. 18.01.2023. Quotation will be opened on 19.01.2023 at 4.00 P.M.
4. The quotation will be received in the office of the undersigned through postal & courier services and by hand. No quotation will be accepted after 1.00 P.M. of dtd. 18.01.2023.
5. The undersigned will not be responsible for late / non-receipt of the quotations sent by post/courier.
6. The envelope should be superscribed on the top "QUOTATION FOR HIRING OF VEHICLE – NOT TO BE OPENED".
7. The quotation should contain the attested Xerox copy of R.C. Book of the vehicle and papers showing up-to-date insurance coverage and the photocopy of the professional Driving License of the driver who is to drive the vehicle.
8. The vehicle will be hired for one year only.
9. The minimum average mileage of the vehicle should be 17 Km/ Ltr. (A/C & Non A/C)
10. Except monthly charges no other charges like maintenance and repair, road tax, insurance premium, salary of the driver etc. shall be paid to the vehicle owner / Travel agency. Office will provide POL & Lubricants as per terms and conditions only.


