At the outset CDVO, Nuapada welcomed all members and bidders/authorized representatives to the technical bid opening process. In response to the Tender call notice no 3253/CDVO NPD dated. 19.10.2022 of CDVO, Nuapada, 9 nos. tender documents (Sl. No.1 to 9) were received within due date i.e., 17.11.2022 3.00 pm for hiring services of Man Power Provider Agency by CDVO Nuapada. Tender documents from M/s. REDTECH Solution India Pvt. Ltd. CDA, Cuttack was received on 22.11.2022 at 1.50 pm i.e., after due date, hence not considered for opening of technical bids.

All the 9 no. tender documents were opened in presence of the District Level Selection-cum-Tender Committee members and the bidders/ their representatives. The Technical Bids and the Financial Bids were separated. All the Financial Bids were kept aside to be opened only after due scrutiny of the Technical Bid along with supporting documents. All Technical Bids were opened one by one. The verification sheet of technical bids is placed at **Annexure-B**. On scrutiny of the technical bids, following facts were found:

1. Techno Facility & management services, chandrasekharapur, BBSR 751016
Submitted all documents as per tender requirement and found to be eligible to participate in opening of financial bid.
2. M/s. Neta Security Services (P) Ltd., soubhagyanagar 1st floor Barmunda, BBSR
Submitted all documents as per tender requirement and found to be eligible to participate in opening of financial bid
3. All in security & intelligence services, Nayapalli, BBSR
During scrutinee it is found that the chartered accountant (CA) report regarding turnover of financial years from 2018-19 to 2020-21 is available but same could not be validated as the UDIN No. is not mentioned. However the committee recommended to take into consideration if the CA report with UDIN No. be submitted. Further the bidder has not submitted the labour licence to ascertain the no of labour for which licence has been issued.
4. M/s. Care Security & Allied Services, Ruchika market, Barmunda, Bhubaneswar
Submitted all documents as per tender requirement and found to be eligible to participate in opening of financial bid
5. M/s. Group No.-5 Security Service, Rasulgarh, Bhubaneswar
Submitted all documents as per tender requirement and found to be eligible to participate in opening of financial bid
6. EMRI green health services, devar yamzal medchal road secunderabad 500078
Submitted all the required documents as per the tender requirement. However after scrutinee following discrepancies found. (a) as per section (i) eligibility criteria serial no.3 the registered office/branch office of the service provider must be located within the jurisdiction area of Odisha & supporting documents like valid address proof of office (copy of telephone/ electricity bill/ valid lease agreement) are to be furnished. But the tenderer have submitted the registered office which is situated in the Telengana state & branch office at Bhawanipatna Odisha in the shape of a rent agreement executed on

Handwritten signatures and dates at the bottom of the page, including dates like 30/11/22 and 30/11/22.

01.10.2022. The stamp paper was issued in the state Telengana not in Odisha. The committee recommended the bidder participation in the opening of financial bid.

7. KAIROS health & composite services, Pvt. Ltd. Somajiguda Hyderabad 500082

Submitted all the required documents as per the tender requirement. However after scrutinee following discrepancies found. (a) as per section (i) eligibility criteria serial no.3 the registered office/branch office of the service provider must be located within the jurisdiction area of Odisha & supporting documents like valid address proof of office (copy of telephone/ electricity bill/ valid lease agreement) are to be furnished. But the tenderer have submitted the registered office which is situated in the Telengana state & branch office at Koraput Odisha in the shape of a rent agreement executed on 01.10.2022. The stamp paper was issued in the state Telengana not in Odisha. The committee recommended the bidder participation in the opening of financial bid.

8. Kalinga Warriors security services BK road Cuttack

Submitted all documents as per tender requirement and found to be eligible to participate in opening of financial bid.

9. Famous Security Services, At- Noornugar Po- Junagarh Dist. Kalahandi.


Submitted all documents as per tender requirement and found to be eligible to participate in opening of financial bid.

After allotment of scrutinee scores basing upon the criteria, the technical score sheets are placed at Annexure-C-1 to C-9. Basing upon the technical score secured, it is found that All in security & intelligence services, Nayapalli, BBSR firm has secured 55 marks out of 100 marks allotted. As per evaluation parameter & Technical bid, the firm has failed to secure a minimum 60 marks, hence not considered for participation in opening of financial bid. Rest eight bidders were considered for participation in financial bid.

The meeting was ended with thanks to committee members and to the chair.



Proceeding of the District Level Selection-cum-Tender Committee meeting for opening of Financial bids of Tender Call Notice No.3253 dated 19.10.2022 and subsequent corrigendum No.3364 dated 31.10.2022 for Hiring of services of Man Power Service Provider Agency was held on Date 15.12.2022 at 11.00 AM in the office Chamber of CDVO, Nuapada

As per decisions of the District Level Selection-cum-Tender Committee meeting held on 30.11.2022 for opening of the technical bids of Tender Call Notice No.3253 dated 19.10.2022 and subsequent corrigendum No.3364 dated 31.10.2022 for hiring of Man Power Service Provider Agency, and subsequent Notice No.3788 dated 01.12.2022, financial bids of all the eligible firms would be opened at 11.00 AM on 15.12.2022 after due scrutiny of the technical bids made on 30.11.2022. All the nine (09) financial bids were kept in a sealed cover with the Chief District Veterinary Officer. Only the financial bids of the eight no. of eligible firms namely 1) M/s. Neta Security Services Pvt. Ltd., 2) M/s. Care Security and Allied Services, 3) M/s. Group No-5 Security Service, 4) M/s. Kalinga Warriors Security Service, 5) M/s. Famous Security Service, 6) M/s. Techno Facility & Management Service, 7) M/s. Kairos, Telengana and 8) M/s. EMRI Green Health Service, Telengana were opened at 11.00 AM on 15.12.2022 by the DLSTC under the Chairmanship of CDVO, Nuapada in the office Chamber of CDVO, Nuapada. The following members were present in the meeting.

Opening of Financial Bids:

At the outset the CDVO Nuapada welcomed all members and bidders/authorized representatives to the financial bid opening process. Out of nine (09) financial bids kept in a sealed cover only eight (08) financial bids of 1) M/s. Neta Security Services Pvt. Ltd., 2) M/s. Care Security and Allied Services, 3) M/s. Group No-5 Security Service, 4) M/s. Kalinga Warriors Security Service, 5) M/s. Famous Security Service, 6) M/s. Techno Facility & Management Service, 7) M/s. Kairos Health and Composite Services Pvt. Ltd., Telengana and 8) M/s. EMRI Green Health Services, Telengana were opened and as the balance 01 no. bidders didn't qualify in the technical bidding process, which are to be returned to the respective firms in original shape.

Observations made:

- A. After opening of the financial bids of eight (08) no. of bidders as mentioned at above, it is found that 1) M/s. Kairos, Telengana and 2) M/s. EMRI Green Health Service, Telengana have not quoted any GST amount applicable in their respective financial bid and they don't have any GST registration in Odisha State. Hence with consultation with the CT&GST Circle Nuapada, as per Section 15(2) (a) of the GST Act 2017, GST will be charged on the Gross amount i.e., the value of

taxable supply. But, both firms have not quoted any GST amount in their financial quotation. They have also altered the F-1 form issued in the tender document.

B. The detailed service charge quoted by the bidders is as follows:

C. It is also observed that M/s. Techno Facility & Management Service have quoted price more than govt. prescribed ceiling and M/s. Kalinga Warriors Security Service have quoted price unreasonably low than govt. prescribed ceiling in-case of Veterinary Doctor.

D. It was observed that there was one typological error issued through Corrigendum Notice No.3364/CDVONPD dtd. 31.10.2022 regarding calculation of Financial score by using factor 0.2 instead of 20, for which the evaluation could not be made.

Decisions Taken:



Level Selection Committee and representatives of the Bidders was Convened on Dt. 03.01.2023 at 11AM in the Officer Chamber of C.D.V.O. , Nuapada regarding discussion on calculation of financial Score of Bidders as $FS=L1(\text{Lowest Quote})/\text{Bidders quote} \times 0.20$. Due to clerical error the calculation percentage was mentioned as 0.20 instead of 20.

All the committee members and representatives of the bidders unanimously arrived at the conclusion regarding taking the Calculation percentage as 20. So calculation shall be $L1(\text{Lowest Quote})/\text{Bidders Quote} \times 20$.

Proceeding of the District Level Selection-cum-Tender Committee meeting for finalization of H-1 Bidder vide Tender Call Notice No.3253 dated 19.10.2022 and subsequent corrigendum No.3364 dated 31.10.2022 for Hiring of services of Man Power Service Provider Agency was held on Date 03.01.2023 at 11.00 AM in the office Chamber of CDVO, Nuapada

As per decisions of the District Level Selection-cum-Tender Committee meeting held on 15.12.2022 for discussion with the bidders/ their authorized representatives regarding calculation of Financial score of bidders, all concerned were intimated vide Letter No.4082(8)/CDVO dtd.23.12.2022 and 4217(8)/CDVO dtd.31.12.2022. to hold a meeting on 03.01.2023 at 11.00 AM in the office chamber of the CDVO, Nuapada. The following members were present in the meeting. The attendance is placed at Annexure- E (1 and 2)

The typological error issued vide corrigendum no.3364/CDVO dtd.31.10.2022 as "Financial score of Individual bidder shall be as (FS): L-1 (Lowest Quote)/ Bidder Quote*0.20" was discussed with the committee members along with the bidders/ their authorized representatives. As per QCBS method the factor of multiplication is 20 instead of 0.20. As all the members & bidders/ their authorized representatives unanimously agreed to rectify the error and use the factor of multiplication 20 for evaluating the financial score.

Accordingly the comparative statement is prepared for financial score (FS) and placed at Annexure-F

In between following objections have been received at the office of the CDVO, Nuapada as follows:

1. M/s. Famous Security Service, Bhubaneswar vide their letter No. Nil dtd.16.12.2022 intimated that (i) bids with Nil or Low service charges can be treated as non-responsive bid which are liable to be rejected, (ii) Service charges quoted with range of 01 paisa to Rs.7/- is unreasonably low to carry out any service providing works and the bidder are non-serious bidder. They have attached Letter No.23170/PR&DW dtd. 11.12.2019 along





with Finance Department Note-sheet. After scrutinizing the said letter & note-sheet, it is clarified that no decisions have been made by the Govt. so far as Budget-V branch of Finance Department is concerned towards minimum Service charges of the Manpower Service provider for finalization of Tender. However as per communications made by Finance Department vide Letter No.29078/F dtd.23.11.2022 for framing a draft guideline on engagement of Consultants and Outsourcing of Service, Para No.6 Service Charges proposed as "The Tender Inviting Authority should define what amounts to negligible service charge in the tender document itself." In this case the Tender Notice No. 3253 dated 19.10.2022 no such clause has been added and no ceiling of service charges are fixed. Hence after intensive discussions, the tender committee decided to go with the clauses published in the tender notice itself.

- M/s. Kalinga Warriors Security services vide their Ref. No.8305 dtd.27.12.2022 intimated that (i) Care Security & Allied Services, (ii) Group No-5 Security Service, (iii) Techno Facility & Management Service being blacklisted by various authorities. However Group No-5 Security Service had submitted vide their letter no. 1125 dtd.25.11.2022 along with extract order copy of Hon'ble High Court of Odisha in W.P.(C) No.26071 of 2021 Para No.7, stated as "Since there is no blacklisting order, it is open to the Petitioner to participate in the tender invited by the authority, as he has not been visited with the penal action of blacklisting." However Care Security and Allied Services & Techno Facility & Management Service have not submitted any clarifications to the office. Hence the tender committee recommended to accept the extract order of Hon'ble High Court of Odisha in respect of Group No-5 Security Service. As there is no other conclusive evidence against the rest two firms, the committee recommended to place the matter before the higher authority for taking a final decision.

Final Evaluation:

Following the QCBS method, QCBS score of each bidder is evaluated as $QCBS = TS + FS$. The Bidder with highest score in the QCBS is declared as H-1 and is the best qualified bidder for the award of contract. The details of draft QCBS is placed at Annexure- G. Accordingly M/s. Kalinga Warriors Security Service is emerged as the H-1. The District Level Selection-cum-Tender Committee recommended to approve the H-1 bidder for issuance of contract and issue work order to execute contract and supply manpower within a period of 15 days, failing upon which the work order shall be issued infavour of the H-2.
