

**TERMS AND CONDITIONS**

1. Sealed Tender for supply of different items/ materials shown in the attached statement are inviting from the intending, Registered and Reputed firm/ suppliers having valid GST registration number.
2. The sealed tender should be sent under strong sealed cover super scribed as TENDER FOR THE SUPPLY OF GROCERY ITEMS FOR SINAPALI KGBV HOSTEL". The sealed Tender must be sent to The Head Mistress, Sinapali , KGBV Hostel (Block-Sinapali ), At-Sinapali, Po-Sinapali, Dist-Nuapada, PIN-766108 through Speed post/Registered post only and the undersigned will not be responsible for any postal delay. The tender will be open in the office of the H.M KGBV, Sinapali on Dt 23.03.2023 at 11 A.M.
2. The rate quoted should include all taxes and transportation charges to the Hostel point.
3. There should not be any overwriting, correction in the Tender. In the absence of the authorized signature in the submitted tender documents, the tender will liable to be rejected.
4. The undersigned does not bind himself to accept the lowest tender and have right to accept the tender in whole or in part i.e with respect to all the articles mentioned in the attached statement or in respect of any one or more than one articles in the attached statement as he/she may decide.
5. On acceptance of the tender it will become a contract and successful bidder shall be bound by the terms and conditions of the tender.
6. The bidder should submit his/ her tender forms along with (i) tender paper cost of Rs.500/- which is non refundable and (ii) Earnest Money Deposit ( EMD) of Rs. 10000/- ( Ten Thousand ) Only in shape of Bank Draft/ Banker Cheque payable at Sinapali in favour of KASTURBA GANDHI BALIKA VIDYALAYA, SINAPALI. The EMD will be refunded to the rejected or unsuccessful bidder. The Earnest money will be forfeited in the event of failure to comply with the contract by the successful bidders. In the event of the Tender being accepted the earnest money will be adjusted towards security deposit. The bidders should not claim for any interest amount for their EMD/ Security deposit. The item/ material wise details for EMD amount are given below –
7. If the successful bidder/ Firm fails to supply the articles within the stipulated time as mentioned in the letter of acceptation/ supply order issued by the Head Master (H.M) of KGBV Hostel, the Hostel shall be at liberty to purchase the articles from the market or get the rest of the contract completed by any other supplier or firm and the difference of price, if any, shall be deducted from the Earnest Money/ Security deposit and in case any amount in excess of the security deposit is paid by the Hostel, the Supplier/Firm shall be liable to pay this amount.
8. The bidder should quote rates only in the prescribed Tender format attached. The rates quoted in other than the prescribed tender format will be rejected.
9. Deposit of EMD and cost of Tender paper are must for all bidders including the registered FSSAI Units. No exemption certificate will be entertained.
10. It is not compulsory on the part of the Hostel to purchases the items for which the tender in being called. The supply order will be placed by the H.M as per requirement. The supplier/ Firm required to supply the quantity of articles as mentioned in the supply order, as per the approved rate, sample and specifications.
11. The Brand/make other than the specification given in the tender documents will not be accepted. Tender Committee may decide the acceptance of items of other brand apart from the brand mentioned in the tender documents.
12. Prior to acceptance of the tender, the Tender Committee reserves the right to call for sample or demonstration and the supplier/ firm shall be liable to supply the sample or give the demonstration and the on free of cost.
13. The approved sample will be kept in the concerned Hostel of verification during the supply of the items/ materials and the same is non-refundable.

14. The rate quoted by the bidder for supply of the items/ materials shall remain unchanged till completion of the contract. No amount amendment in the rate except increase/ decrease in the rate of GST during the period of supplies will be accepted. For the Branded items, if there would be any free gift schemes, the same would be liable to be supplied with the articles of free of cost and also mentioned in the bill. Quoted Rates should not be more the MRP. Sticking of MRP is not allowed.
15. The Security deposit is refundable. The same will be forfeited, when terms and conditions of contract are violated by the supplier, if found. The security money is non-interest bearing.
16. The payment to the supplier will be made in the shape of A/C Payee Cheque, only after verification of the supplied articles by the quality checking committee of the Hostel, scrutiny of the bill, entry in the stock register and after fully supply as order placed with the supplier/ firm.
17. The contract period may be extended with mutual consent of both parties (extra security deposit amount to be deposited by the supplier/ firm).
18. The bidder must apply for all grocery items as mentioned at Annexure-B.
19. The sealed envelope must contain two separate envelopes, one should be super scribed as Technical Bid containing technical Bid documents and other to be super scribed as financials Bid containing financial BID documents. The financial BID will be opened of those bidders whose technical BID will found correct on basis of the term and condition of the Tender.
20. Any dispute regarding the tender process is subject to the jurisdiction of Nuapada district only.
21. The documents to be enclosed while applying for tender:
- I. The technical bid (Annexure-A) should clearly be filled and keep in envelope – I. All the relevant documents of the item maintained in the technical bid are to be enclosed with seal and signature of the bidder/ firm.
  - II. The financial bid ( Annexure-B) containing all the specification with rate of items must be filled up and should be kept in Envelope-II with seal and signature of the bidder/ firm.
  - III. Both the envelopes should be sealed in another envelope. In case of non submission of any required documents, tender of the firm will liable to be rejected.
  - IV. The financial bid will be opened only for those bidders whose technical bid are found eligible.
  - V. Undertaking ( Annexure-C) must be submitted with Technical BID documents by bidder.
  - VI. Check list ( Annexure-D) should be followed by the bidder and must be submitted with Technical bid documents.


