Terms and Conditions of Tender Call Notice for supply of Electronic Automatic Sewing machine to the District Social Security Officer, Nuapada

1. Bidder must be a registered seller on GeM (Government e Marketplace) portal.
2. Sealed tenders are invited from the intending Registered Firms/ Supplying agencies for supply of Electronic Automatic Sewing machine to DSSO, Nuapada.
3. The tender paper containing details terms and conditions, EMD statutory requirement, etc. can be downloaded from the district website www.Nuapada.nic.in. The tender paper cost of Rs.1,000/- (Rupees One thousand) only is non-refundable and and EMD of Rs.12,000/- (Rupee Twelve Thousand) must be attached with the tender paper and both Cost of tender paper and EMD must be in the shape of account payee demand draft/Banker's cheque payable in favour of District Social Security Officer, Nuapada
4. Tender paper complete in all respect along with all required documents should reach in sealed cover to the District Social Security Officer, Nuapada on or before 15.05.2023 up to 12.:00 P.M by Registered/ Speed post only. The tender received beyond the scheduled date and time shall not be taken in to consideration.
5. The tender will be opened on 15.05.2023 at 04.:00 P.M under the Chairmanship of ADM, Nuapada in presence of the members of tender committee and tenderers or their authorized representatives. The details terms and conditions associated with the assignments of tender is mentioned at **Annexure-A**.
6. The tender will be in two parts i.e. Technical Bid (Part-I) and Financial Bid (Part-II). The bidders should submit their Technical bid and Financial Bid separately in two envelopes and put into another large cover superscribed as "Tender for supply of Electronic Automatic Sewing machine to the District Social Security Officer, Nuapada".
7. Bidders who qualify Technical bid will be eligible to participate in Financial Bid.
8. The Successful bidder will deliver the materials to the Office of the DSSO, Nuapada as per requirement within 02 (Two) days from the date of receipt of Purchase order and no transportation charges will be provided to the bidder towards supply of material.
