1. The intending Organization/ Expert/ Architect firm should submit individual sealed cover/ envelope superseding the title "EOI for preparation of DPR "Beautification Mundagaon Pond, Ward No.2, Khariar Road NAC, Not to be opened". Two separate sealed cover to be submitted for 1<sup>st</sup> stage bid & 2<sup>nd</sup> stage bid.
2. More than one quotations would result rejection of all the bid of the same firm.
3. Rate should be quoted clearly both in figure & words including all taxes as a lump sum contract, (excluding GST). Percentage or any other mean of bid will liable to disqualification. If any correction, has to be duly attested by the quotationer.
4. The quotationer should possess prior experience certificate/ completion certificate in similar nature of works. i.e. water bodies, lakes. Work order will not be allowed in this regard.
5. The C.V. of the expert/ consultant has to be enclosed for assessment of experience in prequalification bid.
6. The quotationer should submit detail & satisfactory establishment information capable to undertake such project.
7. The firm / institution should have valid GST Regd. / VAT clearance as well as upto date I.T.C.C. to be accomplished with the bid.
8. initial Security Deposit (ISD) @1% of the bid rounding to Rs.5000/- be deposited in favor of Executive Officer, NAC Khariar Road payable at Khariar Road in shape of D.D. / Bankers Cheque from any Nationalized Bank should be enclosed.
