The vehicle having sitting capacity not more than ten including driver. The quotation should reach the undersigned latest by date.....25.06.2023. upto 1.00 PM . This shall be opened on the next day in the office of the undersigned in presence of quotationers or their authorized representative. The vehicle will be engaged with the following terms and conditions in Annexure-II.

1. The vehicle must be in Road Worthy condition, shall not be more than 3 years old from the date of initial registration and must have valid Registration Certificate, Insurance Certificate, Fitness Certificate, valid contract carriage permit, proof of upto date tax payment etc. which are mandatory for plying of vehicle.
2. The Driver of the vehicle must have a valid driving License for driving light transport passenger vehicle and should be sufficiently experienced in driving transport passenger vehicle.
3. The driver should be well behaved, gentle and good obedient in nature.
4. A sum of Rs. 5000/- shall be deposited by the intending bidders in shape of Account Payee Bank Draft drawn in favour of the Tahasildar, Sinapali and submitted along with the tender as security deposit . After completion of tender process, the amount will be refunded to un-successful bidders.
5. The monthly rate of hire charges be quoted separately in the general bid information (excluding fuel and lubricants).
6. The vehicle must achieve a fuel efficiency of 10 (ten) K.M. per litter.

The details of the make and year of manufacture of the vehicle, registration no., mileage,(Kms covered per letters) and name of the Driver with Driving License No. and period of validity should be specifically provided in the general bid information to be furnished with the quotation (Annexure-III).
