The District Social Security and Empowerment of PWD Section invites EOI from the Registered and experienced NGOs working for the rehabilitation of transgender especially survey, skill development, training and rehabilitation of transgender.

OBJECTIVES:

The District Social Security and Empowerment of PWD Section aims to select successful NGOs for implementation of rehabilitation of transgender especially survey, skill development, training and rehabilitation of transgender.

SCOPE OF ACTIVITY:

1. Survey of Transgender in Nuapada District.
2. Financial support to the parents of transgender children
3. Scheme of pre-matric scholarship for the transgender students studying in classes VII to X.
4. Scheme of postmatric scholarship for the transgender students studying in class IX and above for students in Nuapada District.
5. Assistance for Skill development training to transgender persons.
6. National Pension Scheme for transgender persons.

ACTIVITIES TO BE UNDER TAKEN:

The NGO is required to assist whenever required in the following activities / services for such period as would be approved by the competent authority.

1. Survey of Transgenders in Nuapada District.
2. Financial support to the parents of transgender children
3. Implementation of Scheme of pre-matric scholarship for the transgender students studying in classes VII to X.
4. Implementation of Scheme of postmatric scholarship for the transgender students studying in class IX and above for students in Nuapada District.
5. Assistance for Skill development training to transgender persons.
6. National Pension Scheme for transgender persons.

FACILITIES AND INPUTS:

The competent authority in the District will provide the funds as per the rule in accordance with the responsibilities assigned to them. Non-recurring cost if any should be borne by the selected agency.

ELIGIBILITY CRITERIA:

An agency applying for the programme should fulfil following eligibility criteria.

1. The agency should be working in the field of transgender with proficiency in survey, skill development, training and rehabilitation of transgender.
2. The agency should have work experience of at least **three years** for rehabilitation of transgender.
3. They must have full time regular professionals for conducting the survey, counselling, rehabilitation and implementation of different schemes for transgender.

APPLICATION PROCEDURE:

1. The agency shall be asked to make power point presentation for their proposals before the Committee for necessary evaluation and short listing purpose.
2. The shortlisted agencies shall abide by the terms and conditions as would be laid in the bidding process / documents and as would be approved by the competent authority.
3. The applications / EOIs without support of non-refundable demand draft of Rs. 2500/- payable at Nuapada drawn in favour of **District Social Security Officer, Nuapada** issued by Nationalised / Scheduled Banks in India and non-accompanying other documents shall be summarily rejected.
4. The Collector, Nuapada reserves all right cancel any or all of the applications if found unsuitable to match the requirement.

SUBMISSION DETAILS:

Expression of Interest may be submitted by the interested eligible agencies / NGOs. The document shall include following along with filled up Annexure-I.

- a) Copy of Society /Trust registration certificates of the organisation.
- b) Copy of memorandum and constitution of the association.
- c) Copy of list of Executive / Governing body members.
- d) Copy of PAN Card
- e) Copy of audited statement of Accounts for last three years.
- f) Copy of Income tax returns for the last three years.
- g) Copies of orders by the competent authority for similar projects.
- h) Any other information will may be useful for District Administration, Nuapada in successful implementation of the proposal.
