The quotation in sealed covers must reach the District Election Office, Nuapada by 13/12/2018 up to 1.30 P.M through post/ courier. The quotation will be opened at 4.15 P.M on the same day in the Office chamber of the undersigned in presence of the purchase committee members and in presence of quotationer or their authorized persons. Quotation received after the stipulated time shall not be accepted.

- f. Diameter of Circle: 8 inches
- g. Background colour: Mustard/yellow
- h. Text colour: Black
- i. Position: Either left or right side of the Entry door of Polling Station. It shall be between 6ft to 7ft from the floor level so as to be clearly visible to voter.
- j. No. of Polling Station to be written:- 603 ( List enclosed)

The undersigned reserves the right to cancel the entire process/part without assigning any reason thereof.

1. The rate should be inclusive of all taxes and all other charges including travelling charges.
2. The quotation should furnish rate in Rupees only for one painting/writing.
3. No of booths to be covered :-71-Nuapada -301 & 72-Khariar-302 Total Booths- 603
4. The quotationer should obtain a certificate from the BLO of the PS as token of writing.
5. The quotationer have to deposit EMD amounting to Rs.1000/- (Rupees one thousand only) in shape of cash/Bank Draft infavour of district Election Officer, Nuapada payable in SBI, Nuapada and attached in the quotation paper. Quotation without earnest money will be summarily rejected. The earnest money of unsuccessful bidders will be refunded on the day of finalization.
6. EMD of the successful quotationer will be converted to SD.
7. The quotation will valid up to one year from the date of agreement.
8. The successful quotationer should complete the work within 30 days from the date of receipt of order.
9. In case of failure to comply the order fully or partially as per specification with in stipulate period the SD amount will be forfeited and criminal liability as per Election rule will be fixed.
