The Block Development Officer, Nuapada on behalf of Governor of Odisha invites **Percentage Rate** bids in single cover system for the construction of works as detailed in the table, from the class of eligible contractors as mentioned in column-5 (five) registered with the State Governments and Contractors of equivalent Grades / Class Registered with Central Government / MES / Railways, to be eventually drawn up in PWD P1 Agreement form, for execution of Building/ Road Works. The proof of registration from the appropriate authority shall be enclosed along with the Bid. If successful, the bidder who has not registered under state government has to register under the state PWD in appropriate class of eligibility before signing of the agreement. The bidders may submit bids for the following work.

2. Bids must be accompanied with E.M.D. in shape of N.S.C./P.O.T.D / Post Office Savings Pass Book / Deposit receipt of any Scheduled Bank (Valid minimum one year from the date of receipt) duly pledged in favour of **Block Development Officer, Nuapada.**  
**N.B:- E.M.D. in shape of Cash / Pay Orders or Bankers Cheques / Bank Draft is not acceptable.**
3. The sale of the Bid document shall start from Dt 11.2.2019 and close on Dt.20.02.2019 at 3.00 P.M. in the office of the undersigned. Bids shall be received by this office up to 5.00 PM on date 20.02.2019 through Registered Post / Speed Post only. The authority will not be held responsible for any Postal delay in delivering of the Bid documents or non-receipt of the same.
4. The Bid will be opened on Dt 21.02.2019 at 11.30 A.M. in the office of the undersigned in the presence of the bidders or their authorized representative.
5. Bid documents can be purchased from this office on payment of the tender cost in shape of cash or DD drawn in favour of **Block Development Officer, Nuapada** payable at SBI Nuapada. **This is non-refundable.**
6. The tender documents can be downloaded from <http://nuapada.nic.in> on payment of tender cost of Rs.10,000/- (Rupees ten thousand) only in shape of Demand Draft in favour of **Block Development Officer, Nuapada** and submit the DD in a separate envelope marked "COST OF TENDER DOCUMENT DOWNLOADED FROM INTERNET" along with the tender.
7. Bidders shall submit original affidavit regarding authenticity of their documents and E.M.D along with their bids. Bids shall be accompanied with attested true copy of valid registration certificate, valid VAT/GST clearance certificate and PAN card.
8. The affidavit should clearly speak regarding the name of work for which the tender is submitted. One should mention clearly in the affidavit to avail price preference in case of SC/ST category if any.
9. Engineer Contractor seeking exemption of E.M.D. is required to submit an affidavit to the effect that he has not yet availed the facility for more than two works during the current financial year.
10. **Additional performance security shall be deposited by the bidder when the bid amount is less than the estimated cost put to tender. In such an event, only the successful bidders who have quoted less bid price/rates than the estimated cost put to tender shall have to furnish the exact amount of differential cost i.e. estimated cost put to tender minus the quoted amount as APS in shape of Demand Draft / Term Deposit Receipt pledged in favour of Block Development Officer, Nuapada.**
11. Other details can be seen from DTCN.
12. If stipulation arises, tender will be decided through a transparent lottery system on 21.02.2019 at 1.00 P.M.
13. The authority reserves right to reject any or all the bids without assigning any reason thereof.
