



## TERMS AND CONDITIONS

1. The rate of supply of the material should be inclusive of all taxes/ transportation/ Labour charges etc. per piece. The materials to be purchased should be of very good quality, which can be used at least 05 years.
3. The tenderers have to deposit the E.M.D. / security of the following amount along with Tender Paper of:

Water Cooler with R.O.system 50 Nos	Rs.75000/-

The Tenderers have to deposit the EMD amount as mentioned above in shape of Bank FDR duly pledged in favour of the B.D.O. Nuapada failing which the tender will be rejected out rightly.

4. The successful tenderer should supply the materials within 10 days as per the purchase order at the concerned locations. If the tenderer fails to supply within the specified date, the order would stand automatically cancelled and the EMD/ security will be forfeited.
5. The sealed tenders in plain papers in the proforma should accompany the attested photocopies of the following documents:
  - i) Income Tax PAN card-copy
  - ii) Up-to-date GST clearance certificate and GSTIN No.
  - iii) Photo copy of the Registration Certificate of the GST authority.
  - iv) Photo copy of the Dealership certificate or reseller letter from the company, and the printed company rate of materials for which the rate has been quoted.
  - v) Any other relevant document lawfully required by the Committee.

The original certificates shall be produced to execute an agreement with the Block Development Officer, Nuapada for supply of the materials.

6. The tenders received beyond the stipulated date and time or without all required documents shall be liable for rejection and will not be entertained. The Authority will not be responsible for postal or any other delay for receiving tender papers.
7. The undersigned reserves every right to reject/ cancel any or all tenders without assigning any reasons therefor.
8. The tenderer should bear the responsibility for supply of the materials to the concerned School point and he/she should bear the loss or damage during transit or any damage, compensation to the labourers engaged during supply.
