





Madam,

The undersigned is in receipt of the above refereed letter/show cause notice requiring him to explain the contents of video.

That it's true that we have provided food to our party workers/supporters who have attended the meeting on 25th and 27th of March. Most of them had come from far off place to show their solidarity with the party and the leadership. They had spent so much time and laboured to travel from various location to support the party and my candidature. Its but natural that some water, refreshment and food is provided as per the timing since some of them will go back to their village and reach there at night only. The same is in line with the great Indian tradition and values too.

I firmly believe that providing basic food/water can by no stretch of imagination be termed as Bribery in common parlance and as per the definition provide in the People representation Act too. The relevant provision of the Bribery as defined under Section 123 in The Representation of the People Act, 1951 is quoted below for favour of your kind perusal.

Section 123 Corrupt practices.—The following shall be deemed to be corrupt practices for the purposes of this section—  
(1) "Bribery", that is to say—

(A) any gift, offer or promise by a candidate or his agent or by any other person with the consent of a candidate or his election agent of any gratification, to any person whomsoever, with the object, directly or indirectly of inducing—

(a) a person to stand or not to stand as, or 2[to withdraw or not to withdraw] from being a candidate at an election, or

(b) an elector to vote or refrain from voting at an election, or as a reward to—

(i) a person for having so stood or not stood, or for 3[having withdrawn or not having withdrawn] his candidature; or

(ii) an elector for having voted or refrained from voting;

(B) the receipt of, or agreement to receive, any gratification, whether as a motive or a reward—

(a) by a person for standing or not standing as, or for 4[withdrawing or not withdrawing] from being, a candidate; or

(b) by any person whomsoever for himself or any other person for voting or refraining from voting, or inducing or attempting to induce any elector to vote or refrain from voting, or any candidate 2[to withdraw or not to withdraw] his candidature.

Explanation.— For the purposes of this clause the term "gratification" is not restricted to pecuniary gratifications or gratifications estimable in money and it includes all forms of entertainment and all forms of employment for reward but it does not include the payment of any expenses bona fide incurred at, or for the purpose of, any election and duly entered in the account of election expenses referred to in section 78.

That your honour will appreciate that Party workers and supporters come to show solidarity with the Party and the candidate and providing bonafide and basic courtesy to them cannot be and should not be taken as BRIBERY to seek vote. These person rather go door to door of general public with/without the candidate to seek vote for the party and the candidate. They are/ cannot be bribed by one time lunch/food.

Hope the above will clear the stand of the under signed with regard to the Show cause notice and clarify to you substantially that providing one time food to party workers and party supporters, should not be termed/alleged as Bribery.
