Sealed tenders in the following format are invited from the intending persons for auction sale of the vehicle bearing No. OR-08- 4662 of Tahasil Office, Khariar under the following terms & conditions.

1. The upset price of the Vehicle has been fixed at ₹35,000/- (Rupees Thirty Five Thousand) only and interested bidders has to pay ₹500/- (Rupees five hundred) only in shape of cash towards processing fee in this office.

2. The Tender Papers shall have to be submitted in a sealed cover superscribed "TENDER FOR AUCTION SALE OF THE VEHICLE OR-08-4662" and should reach the undersigned on or before 05.00 P.M. of 29/07/2019 through registered post/ Speed Post only. Tenders received after the due date and time will not be entertained.

3. The tender papers will be opened at 12.00 Noon of 02/08/2019 in the office chamber of the undersigned in presence of the bidders or their authorized representative(s).

4. The E.M.D. of ₹1000/- (Rupees One Thousand) only in shape of NSC/KVP/Postal Time Deposit/Bank TDR should be submitted with the binding paper duly pledged in favour of Sub Collector, Nuapada with the tender documents.

5. The E.M.D. of unsuccessful bidders will be returned soon after completion of the tender process and EMD of successful bidder will be adjusted against the bid amount.

6. The amount should be reflected in words and figures prominently.

7. The interested persons may inspect the vehicle in the premises of the Tahasil, Khariar during office hours on any working days from 18<sup>th</sup> July to 20<sup>th</sup> July 2019.

8. The highest bidder has to deposit 25% of the total bid amount immediately after finalization of the tender and the rest amount within 07 (Seven) days.

9. If the bidder fails to deposit the full amount within the prescribed time the total amount deposited by him will be forfeited and the vehicle will be put to fresh auction.

10. The successful bidder has to lift the vehicle from the premises of Khariar Tahasil within seven days from the date of auction otherwise rent shall be fixed and be realized from him as per Govt. norms.

11. The successful bidder has the responsibility to change the ownership from the competent authority within one month.
