1. Sealed tenders in prescribed proforma are invited from the intending buyers for sale of 75 nos. of confiscated vehicles of Khariar Forest division as mentioned below. The vehicle will be sold on "as is where is basis" and no complain regarding the condition of the vehicles will be entertained afterwards.
2. The intending tenderers are requested to inspect the confiscated vehicles kept at the location as noted against each well in advance before submitting the tender paper. Submission of sealed tenders will be taken as sufficient proof of the tenderers to have inspected the vehicles put for sale and no further complain regarding the vehicles will be entertained on any circumstances.
3. The intending tenderer will have to submit an earnest money (EMD) for vehicles as mentioned against each in the list furnished below in shape of Bank Draft / Bankers Cheque drawn in favour of the Divisional Forest Officer, Khariar Forest Division, Khariar payable at SBI, Main Branch, Khariar along with the sealed tender. Tender papers without EMD in shape of Bank Draft/Banker's Cheque will be rejected out-rightly.
4. If a tenderer wants to bid for more than one vehicle, then he has to apply in separate tender form for each vehicle along with separate Bank Draft/Banker's Cheque. In case of successful tender the EMD amount will be adjusted towards sale value. In case of unsuccessful tender the amount of the EMD shall be refunded.
5. The undersigned reserves the right to accept any bid or reject any or all bids or cancel/withdraw invitation for bid without assigning any reason thereof for such decision. Such decision, by the Divisional Forest Officer, Khariar Forest Division shall not be subject to question by any bidder and the said Divisional Forest Officer shall bear no liability whatever consequent upon such a decision.
6. The tender papers will be received from **01.08.2019 to 27.08.2019** on working days during 10.00 A.M. to 5.30 P.M. in the office of the undersigned. The sealed tender papers may be submitted to the DFO, Khariar (T) Division, At/Po - Khariar, Dist- Nuapada by Regd. /Speed Post or in person dropping in a Box located in the O/o the D.F.O., Khariar Division. The intending tenderers required to submit a copy of Aadhar Card or any authentic identity proof for their identification along with the tender paper. Once the tenderer files the tender paper, it will be presumed that he has already fully satisfied himself about the present condition of the vehicle. The tender papers will be opened on dated **28.08.2019 at 11:00 A.M.** in presence of the tenderers or their authorized representatives with proper identity proof i.e. Aadhar Card or any authentic identity proof.

7. The highest tenderer shall have to deposit 50% of the accepted highest tender amount including the EMD amount and full tax amount under GST as per the rule in force immediately after announcement for the tender result and the rest 50% within 15 days from the date of issue of the ratification order or confirmation of the tender. In case of unsuccessful tender the amount of the EMD shall be refunded soon after declaration of the result.
8. In case of default in payment of highest tender amount by the successful tenderer within the stipulated period from the date of the ratification order; 50% of the tender shall be forfeited to Govt. and the vehicle will be put to a fresh tender sale. The clearance of Road Tax etc. shall be the responsibility of the successful tenderers.
9. The vehicle shall not be delivered to the highest tenderer till full payment is made and other formalities are fulfilled.
10. Once the sale is ratified in the name of the highest tenderers, all the liabilities will be on the tenderer & no claim will be made for any paper and tools etc. which are not available in this office as the vehicles were seized under forest offence cases. The undersigned is not liable for any pending road taxes and changes of ownership of these confiscated vehicles.
11. The successful tenderer shall remove the vehicles from the site within 7 days from the date of deposit of the full amount, failing which ground rent at the rate of 1% of tender money shall be charged for each day or part of the day till its removal. Custody or safeguard of the vehicle shall be the responsibility of the tenderer and no claim or complaint on that account shall be admissible. Where the ground rent so charged exceeds the sale price deposited by him shall be adjusted towards ground rent and the vehicle shall become absolute property of Govt.
