Sealed quotations in plain paper are invited from the interested Travel Agencies/ Tour Operators or Private individuals for providing one Non-AC Diesel driven commercial vehicle preferable one TUV300/ Bolero/ Sumo Gold/ Ertiga for the official use of Tahasildar, Sinapali on monthly hire basis. The vehicle having sitting capacity not more than ten including driver. The quotations should reach the undersigned latest by date 29.05.2020 upto 1.00 PM. This shall be opened on the next day in the office of the undersigned in presence of quotioners or their authorized representative. The vehicle will be engaged with the following terms and conditions.

1. The new vehicle within one year having valid Registration Certificate, Insurance Certificate, Fitness Certificate, valid Contract Carriage Permit, proof of up to date tax payment etc. which are mandatory for plying of vehicle.
2. The details of the make and year of manufacture of the vehicle, registration no., mileage, (Kms covered per litter) and name of the Driver with Driving License No. and period of validity should be specifically provided in the general bid information to be furnished with the Quotation.
3. The monthly rate of hire charge be quoted separately in the general bid information (excluding fuel & lubricants).
4. The vehicle must achieve a fuel efficiency of 10(Ten) K.M per litter.
5. The owner will engage regular driver of its own cost for driving of the vehicle and Driver of the vehicle must have a valid Driving License for driving light transport passenger vehicle and should be sufficiently experienced in driving transport passenger vehicle.
6. The maintenance of the vehicle, repairs of the vehicle, engine oil and other incidental charges as and when required will be borne by the vehicle owner.
7. The insurance (both 2<sup>nd</sup> and 3<sup>rd</sup> party cover), fitness of vehicle, tax payment, pollution free certificate and any other requisite for a vehicle must be updated from time to time by the vehicle owner during the period of contract.
