
**Quotation/Tender Call Notice 01/2020-21**  
**For hiring of Vehicle**

Sealed quotations/ tenders are invited from interested reputed Travel Agencies/ Tour Operators or private individuals for providing 01(one) no of vehicle (Mahindra Bolero-BS-VI) preferably Petrol variant having sitting capacity not more than ten including driver, which shall conform to the Terms and Conditions (Annexure-II) for official use in the CT & GST Enforcement Unit, Nuapada (At- Khariar Road) on monthly rent basis.

- 1) The vehicle must be in Road worthy condition, shall not be more than 3 (Three) years old from the date of initial registration and must have valid Registration Certificate. Insurance Certificate, Fitness Certificate, valid Contract Carriage Permit, proof of up to date tax payment etc. which are mandatory for plying of vehicle.
- 2) GST registration and GeM registration are compulsory for the service provider to provide hired vehicles to Government offices through GeM or through open bidding.
- 3) The Driver of the vehicle must have a valid Driving License for driving light transport passenger vehicle and should be sufficiently experienced in driving transport passenger vehicle.
- 4) The Driver should be well behaved, gentle and obedient in nature.
- 5) A sum of Rs. 5000/- (Rupees Five thousand only) shall be deposited by the intending bidder in shape of Account Payee Bank Draft drawn in favour of the **Deputy Commissioner of CT & GST, CT & GST Enforcement Unit, Nuapada** and to be submitted along with the tender as security deposit. After completion of the tender process the amount will be refunded to unsuccessful bidders.
- 6) The monthly rate of hire charge be quoted separately in the general bid information (excluding fuel and lubricant).



- 7) The Vehicle must achieve a fuel efficiency of 10(Ten) kms per litre.
- 8) The details of the make and year of manufacture of vehicle, Registration No, mileage (kms covered per litre) and name of the Driver with Driving License No. and period of validity should be specifically provided in the general bid information to be furnished with the Quotation/Tender (Annexure-III).
- 9) The Quotation completed in all respect should reach the undersigned on or before 14.10.2020 by 5.00 P.M. and shall be opened on 15.10.2020 at 1.00 P.M. in presence of bidders or their authorized representatives.
- 10)The application form of quotation/ tender containing general Bid Information & Terms and Conditions for Hiring of Vehicle will be available at the office of the **Deputy Commissioner of CT & GST, CT & GST Enforcement Unit**, Nuapada (At- Khariar Road) on payment of Rs. 200/- from 29.09.2020 to 07.10.2020 during the office hour on working days which is non-refundable or can be downloaded from the website [www.nuapada.nic.in](http://www.nuapada.nic.in) from dt.29.09.2020 to dt.07.10.2020 .The applicant shall furnish a Demand Draft for an amount of Rs. 200/-(Rupees Two Hundred only) in favour of the **Deputy Commissioner of CT & GST, Enforcement Unit, Nuapada** payable at SBI Main Branch , Nuapada towards the cost of application along with the application.

- 12) The Authority reserve the right to reject any or all tenders without assigning any reason whatsoever





**Annexure - II****TERMS & CONDITIONS FOR HIRING OF VEHICLES**

The following terms and conditions must be fulfilled by the successful bidder for providing a vehicle on hire on monthly rent basis.

1. The hired vehicles, during period of contract, shall have all necessary valid MV documents such as : - valid Registration Certificate, Insurance Certificate, Fitness Certificate, valid Contract Carriage Permit, proof of up to date tax payment etc. and D.L. of the driver available all the times. The Department/ Office hiring the vehicle shall not be responsible for any damage/ loss caused to hired vehicles or loss of life / injury made to any person or damage to any property on account of use of hired vehicle any manner whatsoever. The hirer shall be responsible for all such litigation.
2. The hire charges to be paid for monthly basis is final but does not include cost of diesel, which is to be paid separately basing on actual consumption and lubricants as per existing Government norms. All the expenditure of the vehicle towards repair, replacement of spare parts, Lubricating oil of Engine, Gear Box & differential Coolant, Tyres & Tubes, Battery etc. will be borne by the bidder.
3. It shall be the responsibility of the bidder to provide a good driver and the salary of the driver shall be borne by the owner.
4. In case of breakdown for reasons whatsoever the replacement of a vehicle of the same or better model shall be provided by the owner of the vehicle/bidder.
5. In case of the vehicle do not report regularly, the authority will be at liberty to reject the agreement and may engage vehicle from other source.
6. The vehicles shall report for duty for minimum of 25 days in a month.
7. In case of emergency, the driver will have to report for duty as per the requirement of hirer. No extra payment shall be demanded.
8. Monthly hire charges and reimbursements towards cost of diesel (as per actual) and lubricants ( as per Govt. norms) of selected bidder will be paid in every succeeding month, as per as possible within fifteen days of the submission of bills by the service provider and no advance payment will be made.

- 9 The vehicle shall not be more than 3 years old from the initial registration and also in good running condition during the period of contract.
- 10 If the services are found to be unsatisfactory, the client shall give ~~three~~ *three* months notice and terminate the agreement.
11. In case the service provider intends to withdraw the services of his vehicle and terminate the agreement, it shall be mandatory upon him to grant ~~three~~ *three* months notice before such withdrawal of service and termination of agreement.
- 12 If the bidder violates any of the terms of contract, Government shall forfeit the entire amount of security deposit.
