In pursuance to letter No.7596/Ex.dt.15.09.2021 of Excise Commissioner, Odisha, Cuttack, it is hereby informed to all that the condemned Government Jeep attached to District Excise Office, Nuapada bearing Registration No. OR-08-8152 Mahindra & Mahindra make Commander, Engine No.DV-252292 and Chassis No.CDR-650MD-2CV-DV-252292 shall be put to auction sale on dt.29.10.2021 at 11.00 A.M In the office chamber of Superintendent of Excise, Nuapada as per the following terms and conditions. The vehicle is kept in the campus of District Excise Office, Nuapada. The intending bidders may inspect the vehicle in any working day during the office hour i.e.10.00 A.M. to 5.00 P.M, the upset price of the said vehicle has been fixed to and approved to Rs.22,000/- (Rupees Twenty two thousand) only.

Terms and conditions:-

1. No Bid shall be accepted less than the upset price.
2. The intending bidder shall deposit Rs.1,000/- (Rupees One thousand)Only in cash towards caution money before the Inspector of Excise, Sadar Range, Nuapada on or before the date of commencement of auction.The caution money shall be refunded to the unsuccessful bidder immediately after the auction is over and in case of auction purchase of the successful bidders, the amount shall be adjusted towards the Auction Bid money.
3. The highest auction purchaser shall have to deposit the approved amount immediately after the auction is over in the Office of the Superintendent of Excise, Nuapada. If he/she fails to deposit the amount, the authority shall cancel the auction and he may put the vehicle on the re-auction.
4. It is the responsibility of the auction purchaser to shift the said vehicle from Office campus of the District Excise Office, Nuapada within three days, failing which ground rent @Rs.10/- per days shall be realized from him.
5. The auction conducting authority reserve the right to reject any bid without assigning any reason thereof.
