



Terms & Conditions for disposal of condemned EMAS Ambulances (108) through Auction Sale Notice.

- Condemned Ambulances are to be disposed-off along with location and off set price is annexed in Annexure 3.
- The participants may inspect the ambulances at places/location mentioned against each on as is where basis in the premises during the office hours with permission from the CDM & PHO, Nuapada.
- Ambulances will be auctioned in "as is where basis".
- The terms, conditions and guidelines for Bidders should not be submitted with the TENDER FORM. Only filled up the tender form should be submitted.
- Tender shall be submitted in " TENDER FORM" **Annexure-1**
- Any mistake noticed in the Tender Form will be decided by the Tender screening committee and its decision will be final.
- The bidders shall quote the rate visibly in words (Block letters & Numerical) to avoid confusion.

- Intending bidders shall have to enclose a Bank draft/Banker cheque of Rs. 2, 500/- (Rupees Two thousand Five hundred only) as Bid Amount (EMD) **for each vehicle** for which bid is submitted which is non refundable and the same will be submitted along with Tender Form. This will be drawn in State Bank of India, Nuapada or any Nationalize Banks in favour of Non-NRHM Account ZSS, O/O Chief District Medical & Public Health Officer, Nuapada and should be submitted along with the tender paper failing which the tender will not be accepted.
- The bidders are required to submit photocopy of PAN card/Adhar Card/Voter Id/Pass Port along with the sealed bid.
- Non submission of any documents leads to automatic cancellation of participation in the auction process and the cost will be forfeited.
- No undertaking for submission of documents is allowed
- The bidder quoting highest price approved by the authority will be asked to deposit 25% of the quoted rate immediately on confirmation of acceptance of tender and the rest amount of 75% should be deposited within 7 (Seven) days through Demand Draft/Bank Draft from any nationalized bank in favour of CDM & PHO, Nuapada. In case of failure to pay the amount, the deposited amount will be forfeited and the vehicle will be offered to the bidder quoting next highest rate.

- The tenderer will remove the vehicle from the site within 7 (Seven) days of payment of money in full. The safeguard and custody of the vehicle shall be responsibility of the tenderer. No claim or complaint in this regard shall be entertained by the undersigned.
- In case of dispute or any matter the interpretation & discussion of the authority shall be final & binding and the legal procedures if any should be in the jurisdiction of Nuapada district.
