

2. The quotationer must have a valid authorization.
3. Rates should be inclusive of all taxes, Transportation & Delivery.
4. The rate will be applicable for purchase of the above mentioned items for the period of Two year.
5. The supplier selected shall have the responsibility to supply above mentioned items as per supply order which is required for carrying out day to day official work.
