

The quotations will be opened on the same date in presence of the Quotation or their authorized agents and committee members at 2.30 PM in the Conference Hall of Collectorate, Nuapada.

The sealed envelope containing the proposals must be delivered to the office of the DEO & Collector, Nuapada by Registered Post/Speed Post of Indian postal Deptt. or dropped in the assigned box at the DEO's office. No other mode of delivery shall be accepted. The envelope should **super-scribed** QUOTATION FOR QUATATION NO. DATED.

Conditions:

1. The vendor has experience and software support for doing such web-casting and the Internet availability & connectivity.
2. The rates quoted by the bidders are valid for a period of one year

- from the date of signature of agreement/ finalization of tender.
3. The required quantity of aforesaid equipment need be supplied by the supplier within five days from the date of receipt of supply order for which the firm should be committed.
  4. The authority reserve the right to approve or cancel any or parties full of the quotations without assigning any reason thereof.
  5. The Selected vender have to deposit security money amounting to Rs.10,000/- (Rupees Ten thousand) only in shape of Bank draft drawn in favour of District Election Officer, Nuapada payable at Nuapada.
