2. The organization should have valid registration certificate under the Society Registration Act. (1960) by State Board.
3. Recommendation for the awards along with duly filled application form shall be sent through District SPCA entity to State Animal Welfare Board.
4. An Individual with social reputation may recommend a name of an organization to the Dist SPCA for the award with sufficient documentary proof.
5. All the applications received from Dist SPCA shall be scrutinized by a Selection Committee constituted by the Member Secretary of Board.
6. The committee shall shortlist and finalizes the list of awardees out of the applications received from dist SPCA for the Awards considering the achievements of the organizations.
7. The Selection Committee may at its discretion also consider the Animal Welfare Organizations apart from the recommendation received from SPCA, if they found more eligible organization, with proper justification and proof.
8. The decision of the Selection Committee shall be final and binding. No correspondence will be entertained with respect to the decisions taken by committee, from anybody.
9. The Board reserves its right to reject, disqualify, any or all applications/ recommendations without assigning any reason to anybody or organization.
10. Application will only be accepted for the specified categories.
11. There is no Application / Nomination fee for the award.
12. All application forms and the information/documents provided therein shall remain confidential and shall be the property of the Board. Names and contact details will not be shared in any circumstances to anybody or organization.
13. Upon submission of application form, the applicant agrees that the Board may use the information provided in the application form for press purposes and publishing case studies, etc.
14. Incomplete application form shall be out rightly rejected by the selection Committee. The applicant shall undertake to abide by the rules and regulations/guidelines of the Award and shall accept the decision of the Award / Selection Committee as final in all respects.
15. The application should be duly filled in English or Odia (preferably typed).

Criteria for Award to AWO involved in Animal Welfare Activities

SAWB is constituted under the Prevention of Cruelty to Animals Act (PCA) 1960. The Prime functions of this Board includes the promotion of Animal Welfare for Prevention of Cruelty and for protecting animals from being afflicted with or vulnerable to unnecessary pain and suffering.

The Board intends to give away the award annually to the NGOs passionately involved in various Animal Welfare activities throughout the year.

The SAWB will invite applications from the eligible organization for award "Prani Mitra" to acknowledge their recognition and contribution towards the cause of animal welfare and protection.

The award is intended to be given away basing on the following characteristics and requisite criteria as follows:

● **Criteria for AWOs :**

- The Animal Welfare organization (AWO) must have been a registered organization through State Animal Welfare Board.
- The Animal Welfare organization must not have been ever blacklisted for its ill deeds by the State Board.
- Uninterrupted functioning in the field of Animal Welfare in the last one year.
- Sheltering, rescuing and facilitating veterinary service to homeless/abandoned/disabled/injured/non-productive animals in the last one years.
- Facilitation of vaccination/immunization of animals.
- Holding public awareness campaign in rural and urban areas regarding different aspects of Animal Welfare and PCA act, 1960.
- Proof relating to activities may be given through annual report of the organization or photographs or paper clip or video clip of the year.
- Involvement in any exemplary activities for prevention of cruelty to animals, for example: seizure of illegal transportation of animals with the support of the police or villagers, etc.

Terms and Conditions:

1. The Animal Welfare Organizations operating in the state shall be eligible to apply for the award without any distinction or discrimination on grounds of race, caste, creed, religion or sex, etc.
