At the outset, the Chairman welcomed all the members and bidders to the meeting and requested the Section Officer, O/o the CDVO Nuapada to present the bids to the house.

Then the Section Officer, O/o the CDVO Nuapada informed the house that in response to the limited tender enquiry issued vide bid reference no cited above, a total four bids have been received and requested the house to start the evaluation process. Then the Chairman requested the house to start opening of the bids as per the terms and conditions laid down in the tender document.

Then the Committee Members opened the Sealed Tenders in presence of bidders and their representatives observing all formalities and examined the documents as per terms and conditions laid down in the tender document and summarized its observations in the Annexure I. After careful examination and thorough discussion on the comparative statement, all the four bidders qualified the examination of the Technical Bid as per tender terms and conditions and it was unanimously decided to go for price bid evaluation of all four bidders.



In the end the meeting concluded with vote of thanks to the Chair and all the participants.





PROCEEDINGS:

A meeting of the Tender Evaluation Committee, duly constituted with the kind approval of the Collector and DM, Nuapada was held on 02.11.2023 at 5 PM in the Office Chamber of the CDVO Nuapada for finalization of the bids on "SUPPLY OF KIT BAGS FOR MATSYA O PRANISAMPAD MELA 2023" issued vide Bid reference No 4162 Dt 18.10.2023. At the outset, the Chairman welcomed all the members and bidders to the meeting and requested the Section Officer, O/o the CDVO Nuapada to present the bids to the house.

Then the Section Officer, O/o the CDVO Nuapada informed the house that in response to the limited tender enquiry issued vide bid reference no cited above, a total four bids have been received and requested the house to start the evaluation process.

Then the Committee Members opened the Sealed Tenders in presence of bidders/ representatives observing all formalities and examined the documents as per terms and conditions laid down in the tender document.

After opening the bids, it was found that a bidder K. Moulidhar has submitted only the financial bid without any documents and sample, hence the bid was rejected. The house examined other three bids and summarized its observations in the Annexure I. After careful examination it was found that Maa Mangala Traders, Malkanagiri has only submitted the PAN and GST registration number without any other documents and sample requested in the bid, hence the committee decided not to consider his financial bid.

Then the house opened the samples and price bids of the remaining two bidders. The price bids were summarized in the Annexure II and the samples were examined. The sample of Sarawati Suppliers, Kantilo, Cuttack was found to be grossly inadequate as per the schedule of requirement outlined in the bid, was of very low quality, and the price quoted was exorbitantly higher for the material quality and make of the product. Hence the house rejected the sample outrightly. The sample submitted by the Maa Mangala Traders, Jeypore was found to be in complete conformity with the schedule of requirements outlined in the bid document but the price quoted (Rs 247.34) was higher than the maximum bid price. Since one sample was rejected by the house leaving behind only one eligible sample, the sample evaluation process outlined in Section IV-23 could not be followed.

Moreover, due to urgency of the event and paucity of time for fresh tender, the House unanimously decided to open discussion to negotiate for arriving at an agreeable price for the product. At first, the house asked Saraswati Suppliers, Kantilo, Cuttack, whether he would be able to supply a kit bag of equivalent quality and make as submitted by Maa Mangala Traders at a lower price quoted by him and allowed him one day time to decide by consulting suppliers and his firm.

Finally, Saraswati Suppliers, Kantilo, Cuttack verbally expressed his inability to do so. Then the House negotiated with the Maa Mangala Traders, Jeypore and finally arrived at a negotiated price of **Rs 246.00 per bag** by mutual consent.


In the letter No 13763/FARD Dated 03.10.2023 by the Principal Secretary to Govt. of Odisha, at F&ARD Department addressed to all Collectors at Annexure A-4 and Annexure VII-13, Kit bag mentioned for farmer participants included Kit bag printed with logo and mascot, I Card for participants, Pen, Pad, Programme of the Mela, Leaflets/Brochures on Govt schemes with a total price of Rs 400.00 per participant. During bid document preparation the Tender Evaluation Committee approximately assigned Rs 200.00 per bag with printing of logo leaving the remaining Rs 200.00 for the other components. After learning that Kit Bags of required specifications are not available in the market for the maximum price stated in the bid and there is scope for upgrading the price in that component, the Committee felt it justified to arrive at a price slightly higher than the maximum bid price by negotiative discussion in public interest.

Hence, for time bound execution of Matsya O Pranisampada Mela and pressing need for procurement of the product with customized printing, the house unanimously decided to select the Kit Bag submitted by **Maa Mangala Traders, Jeypore** at a negotiated price of **Rs 246.00 per bag** in the best interest of public service and recommended the Tender Inviting Authority to issue Letter of Award in favor of the bidder and procure the goods by observing all financial formalities.

Finally, the meeting ended with vote of thanks to the Chair and the participants.






