A meeting of the Tender Evaluation Committee, duly constituted with the kind approval of the Collector and DM, Nuapada was held on 09.11.2023 at 3 PM in the Office Chamber of the CDVO Nuapada for "SUPPLY OF VETERINARY MEDICINES FOR MVUs AND VETERINARY INSTITUTIONS OF NUAPADA DISTRICT FOR THE YEAR 2023-24" issued vide Bid reference No 4035 Dt 09.10.2023. At the outset, the Chairman welcomed all the participants and informed the house that in response to the tender call notice issued above a total of 4 bids have been received and requested the house to begin evaluation of the Technical bids as per the Schedule.

Then the house opened and examined the technical bids in presence of the representative of one bidder and summarized its observations in the Annexure I.


Analysis of and a thorough discussion on the comparative statements of all the bidders revealed that:

1. Winner's Pharma, Cuttack has submitted the annual turnover statement in a different format with a Charters Accountant's Audit report having a valid UDIN Number for the year 2021-22 with annual turnover of Rs 7,73,29,815.00. Since the bid document required an average annual turnover of Rs 20 lakh, the house decided to qualify the bidder in Technical Evaluation.


2. M/S Prakash Pharmaceuticals, Rourkela & M/S Nikhil's Pharamaceuticals, Attabira have submitted IT return for the AY 2020-21, 2021-22, 2022-23. Since they have submitted the returns for continuous 3 years, the Committee allowed their bid to qualify the technical evaluation.




PROCEEDINGS:
