PROCEEDINGS:

A meeting of the Tender Evaluation Committee was held on 16.12.2023 at 11 AM in the Office Chamber of the CDVO Nuapada for finalization of the bids on "WALL PAINTING ON ARD SECTOR SCHEMES IN NUAPADA DISTRICT" issued vide Bid reference No 4899 Dt 01.12.2023. At the outset, the Chairman welcomed all the members and bidders to the meeting and requested the Section Officer, O/o the CDVO Nuapada to present the bids to the house.

Then the Section Officer, O/o the CDVO Nuapada informed the house that in response to the limited tender enquiry issued vide bid reference no cited above, a total number of six bids have been received and requested the house to start the evaluation process. Then the Chairman requested the house to start opening of the bids as per the terms and conditions laid down in the tender document.

Then the Committee Members opened the Sealed Tenders in presence of bidders and their representatives observing all formalities and examined the documents as per terms and conditions laid down in the tender document and summarized its observations in the Annexure I. After careful examination and thorough discussion on the comparative statement, five out of six bidders qualified the examination of the Technical Bid as per the Tender terms and conditions. One bidder named M/S SARASWATI SUPPLIERS had an average annual turnover of 25.23 lakhs over last 3 years and hence it was unanimously decided by the committed not to open its price bid.

Then the house proceeded for evaluation of price bids of the remaining five bidders. The price bids were opened and the contents were summarized in Annexure II. The house decided to compare the base price quoted by the bidders for finalization of L1 bidder. On careful examination and analysis of the comparative statement, the
