Sealed tenders are invited from the eligible bidders as per the eligibility criteria for supply of following particulars under CDM & PHO, Nuapada

01. Ambulance – 1 Nos.

The above numbers may be increased or decreased as per the decision of the committee.

1. The bidders have to submit their tenders in separate sealed covers (i.e. Cover "A"-Technical Bid & Cover "B"- Price Bid). Both the covers should be put into a third Cover "C" which must be super-scribed as "Tender for "supply of Ambulance ".

2. The Cover "A" (Technical Bid) should contain as follows: -

- a) Checklist with details of the documents enclosed in Cover "A" (as per Annexure - I) with page number. The document should be *serially arranged* as per this Annexure - I and should be securely tied and bound.
- b) Manufacturing unit / supplier, who has been blacklisted either by the Tender inviting authority or by any state Govt. or Central Govt. organization, is not eligible to participate in the tender for that item during the period of blacklisting. They should submit a declaration about this by a **Notary Public (Annexure – IV)**.
- c) EMD Rs.20,000/- (Rupees Twenty Thousand only - Refundable) in shape of Bank Draft / Bankers Cheque in favour of CDM & PHO, Nuapada payable at Nuapada
- d) Tender Paper Cost Rs.2,000/- (Rupees Two Thousand only – Non-refundable) in shape of Bank Draft / Bankers Cheque in favour of CDM & PHO, Nuapada payable at Nuapada

- f) List of Item (s) Quoted individually in the prescribed format. (**Annexure – II**).
- g) Copy of organization PAN.
- h) Copy of organization Income Tax Acknowledgement Report (**Assessment Year 2023-24**) and copy of the audited financial statement for the last three **financial years**.
- i) Photocopy of the up to date GST Registration certificate and last three month GST return copy i.e. (Sept, Oct & Nov 2023).
- j) Copy of Valid Manufacturing License of the manufacturer (s) / Import License by the Importer (also to be submitted by the authorized distributor).
- k) Copy of valid ISO Certificate.
- l) All the tender documents should sign by the bidders at the bottom of each page with his official seal duly affixed.
- m) Leaflet / Technical Brochures of the products / item offered.
- n) They should quote the rates inclusive of excise duty, insurance, packing, forwarding, freight (door delivery) and excluding GST (if any) and should submit a self declaration about this.
- o) They must submit the undertaking that they will supply the stocks **within Fifteen days** after receipt of the Purchase Order from this office.
- p) The supplier shall have a minimum annual average turnover of Rs. 50 Lakh or more in the last three year financial years i.e. 2020-21, 2021-22 & 2022-23 and copy of the audited financial statement for the last three financial years.

3. General Condition:

- a) Eligible bidders should submit their tender documents to the CDM& PHONuapada through **Speed Post / Registered Post** with in the stipulated date & time as mentioned in the tender notice.
- b) Any tender documents received after the due date & time will be rejected and returned to the sender unopened.
- c) Violating the tender terms and conditions & non-supply / partially supply / supply, which is not as per technical specification, will declared as **Blacklisted** and disqualify the firm to participate in any tender of this district for a period of next 03 (three) years from the date of issue of the letter and their E.M.D. will be forfeited.
- d) Tenders documents should be typewritten or computerized, failing which the bidders will be ineligible for consideration. No further correction will be allowed.
