PROCEEDINGS:

A meeting of the Tender Evaluation Committee was held on 06.01.2024 at 11 AM in the Office Chamber of the DFO, Nuapada for finalization of the bids on "WALL PAINTING ON FISHERIES SECTOR SCHEMES IN NUAPADA DISTRICT" issued vide Bid reference No 1970 Dt 28.12.2023. At the outset, the Chairman welcomed all the members and bidders to the meeting and requested the AFO, Nuapada to present the bids to the house.

Then the AFO, Nuapada informed the house that in response to the limited tender enquiry issued vide bid reference no cited above, a total number of Seven bids have been received and requested the house to start the evaluation process. Then the Chairman requested the house to start opening of the bids as per the terms and conditions laid down in the tender document.

Then the Committee Members opened the Sealed Tenders in presence of bidders and their representatives observing all formalities and examined the documents as per terms and conditions laid down in the tender document and summarized its observations in the Annexure I. After careful examination and thorough discussion on the comparative statement, Five out of Seven bidders qualified the examination of the Technical Bid as per the Tender terms and conditions. Bidder named Debadutta Joshi, Khariar & Eye Ball promotions Pvt.Ltd., BBSR did not submitted required documents and hence it was unanimously decided by the committed not to open its price bid.

Then the house proceeded for evaluation of price bids of the remaining five bidders. The price bids were opened and the contents were summarized in Annexure II. The house decided to compare the base price quoted by the bidders for finalization of L1 bidder. On careful examination and analysis of the comparative statement, the house selected Batra & Batra Electronics, Khariar Road, Dist-Nuapada as the L1 bidder with a base price of Rs 800.00 and total price of Rs 944.00 with GST per one wall painting and recommended the Tender Inviting Authority to issue Letter of Award in favor of the successful bidder and execute the work by observing all financial formalities.

In the end the meeting concluded with vote of thanks to the Chair and all the participants.
