2. Bidding documents can only be available on-line in the Government of Odisha website [www.tendersodisha.gov.in](http://www.tendersodisha.gov.in) from **11:00 AM on 03.02.2024 and up to 5:30 PM on 12.02.2024** for preview, download & submission.
3. The Bidders desiring to participate in "On-line" bidding must possess compatible **Digital Signature Certificate of Class-II or Class-III**. The web site for the on-line bidding is <http://tendersodisha.gov.in>.
4. The cost of tender paper as tabulated in the annexure shall be received **online** along with the bids as per guideline issued by Works Dept O.M No 6785 dated 09.05.2017 and No 17254 dated 05.12.2017. The procedure of bid submission using electronic payment of tender paper cost by the bidder may be referred in Works Dept O.M No 17254 dated 05.12.2017 which has been added to the DTCN.
5. Bidders desirous to hire machineries or equipments from outside the State or owned but deployed outside the state are required to furnish 2% of the amount put to tender as Bid Security (Col-4) instead of 1%. **The bidders shall have to furnish 1 % of tender amount towards Bid Security as EMD on Online failing which the tender will be rejected.** Further, wherever, there are compelling circumstances to ask for Bid Security, the same should be done only with the approval of the next higher authority to the authority competent to finalize the tender. If they withdraw or modify their bids during period of validity etc., they will be suspended for the time specific in the tender documents.
6. The successful bidders will have to deposit remaining bid security @1% i.e. ISD (Initial Security Deposit) of the agreement value in the form of Term Deposit receipt of any Nationalized bank duly pledged in favour of the Superintending Engineer, Minor Irrigation Division, Khariar, Nuapada and payable at S.B.I. Nuapada as per the terms & conditions laid down in OGFR and in no other form during execution of the agreement.  
**N.B.** a) No Cheque / Bank draft / Cash Payment will be accepted.  
b) Adjustment of earnest money given with other tenders previously and submitted with other tenders shall not to be entertained.
7. Tender shall be uploaded in standard formats prescribed in the bid documents displayed at Govt. of Odisha e-market place web site & submitted duly filled up. The on-line bidders should upload the **scanned clear copy** of the **affidavit** in support of correctness or proof of the information submitted including bid security accompanied with tender by them. They should **digitally sign** on all statements, documents, certificates uploaded by them, owning responsibility for their correctness/ authenticity. If the documents are not digitally signed, an **affidavit** owing genuineness of the documents should be uploaded. **The affidavit of authenticity of documents uploaded by the bidder being a legal document, checking genuinely of signature put on other uploaded documents including affidavit and lease deeds is beyond preview of the officer inviting tender. The bidder himself is liable for the authenticity of the documents if challenged by any other bidder or in the court of law.**
8. One bidder can submit only one tender paper for each of the works for which tender invited in this notice in his own DSC. Submission of more than one tender paper for any particular of work by a bidder through different DSC or through his own DSC for a particular tender will be liable for rejection of all such tenders.
9. **Engineering Contractors wishing to avail exemption of EMD shall furnish an affidavit to the effect that he has not availed the benefit for more than two times during this financial year and original license shall be**

submitted before the authority for making necessary entry in the original license, if successful & selected for awarding the work as per Letter No FA-Codes-6/2011- 600 dated 18.1.2011 of Works Department. Non response of successful bidder to deposit additional performance security deposit in shape of NSC/ Post office savings Bank account/ Post office Time Deposit Account/ Kisan Vikas Patra/ Bank Guarantee pledged in favour of the Superintending Engineer within seven days, otherwise the bid shall be cancelled and the security deposit shall be forfeited and **blocking of D.S.C. and license issuing authority will be moved for cancellation of contracting license.**

10. Additional Performance Security shall be obtained from the bidder when the bid amount is less than estimated cost put to tender. The successful bidder who has quoted less bid price/rates than the estimated cost put to tender shall have to furnish the Additional Performance Security at following rate as per O.M.No.4559 Dated. 05.04.2021 of works Department Govt. of Odisha.



11. The contractor should have registered his/her name in Contractors Database Management System (CDMS) irrespective of tender amount in concurrence to Letter No.30613, dt.22.07.2019 of Engineer-in-Chief (Civil), Odisha, Bhubaneswar. Non registration in CDMS portal is liable for rejection of the tender.
12. The amount quoted by bidders shall remain **valid for 90** (ninety) **days** from the date of opening of financial bid. If any bidder backs out from the bidding process, or make any request for alteration or modification in terms & conditions of the bid shall debar the bidder from participating in the online bidding system and his portal registration shall be blocked including recommendation to registering authority for cancellation of his/her registration as contractor including forfeiture of bid security deposited.
13. The bidder shall have to furnish **No relation certificate as on schedule-A** in DTCN.
14. The bidder shall have to furnish the information regarding current **litigation, debarring, expelling of tendered or abandonment of work by the tenderer as per schedule "B"** in DTCN.
15. The bidder shall have to furnish **Affidavit about authenticity of documents in proper format as on schedule "C"** in DTCN.
16. If L1 bidder does not turn up for agreement after finalization of tender, then he shall be debarred in participating in bidding for three years and action will be taken to blacklist the contractor. In that case the L2 bidder if fulfils all other criteria would be called for drawing agreement for execution of work subject to the condition that L2 bidder

- negotiates at par with the rate quoted by the L1 bidder, otherwise tender will be cancelled.
17. If rate quoted by a bidder is less than 15% of the tendered amount, then such a bid shall be rejected and tender shall be finalized basing on merits of rest of bids. But if more than one bid is quoted up to 14.99% (Decimals up to two numbers will be taken for all practical purposes) less than the estimated cost, the tender accepting authority will finalize the tender through a transparent lottery system where all bidders/ their authorized representatives, the concerned Superintending Engineer and DAO will remain present. Successful bidder should sign the agreement.
  18. Office Memorandum File No. 07556900042013 (PtII)-7885/W dated 23.7.2013 will be treated as part of DTCN and instruction to bidder. (Enclosed to DTCN)
  19. **Payment will be made as per the availability of Funds.**
  20. Other details can be seen from the bidding document.
  21. **Submission of fake NSC/ Post office savings Bank account/ Post office Time Deposit Account/ Kisan Vikas Patra/ Bank Guarantee shall lead to rejection of Bids and criminal action shall be initiated against the concerned bidders.**
  22. **GST to be imposed as per Govt. guidelines from time to time.**
  23. **The bid documents should be uploaded by the bidder accompanying copies of Registration, GST Certificate, PAN Card, Cost of tender papers, Affidavit about authenticity of documents, Affidavit about current litigation & Debarring and No Relation Certificate in Prescribed proforma provided in DTCN else the bid will liable for rejection.**
  24. The authority reserves the right to reject any or all the bids without assigning any reason thereof.
  25. **The bidder must provide the mobile No and e-mail ID along with the tender documents for official correspondence, if any. No paper correspondence shall be made in this regard to avoid delay in finalization of tender. In case of lottery need to be conducted in accordance with the works department order no.12366 dtd 8.11.2013, (THIS OFFICE WILL NOT BE HELD RESPONSIBLE FOR NON-INTIMATION OF MOBILE NO/ E-mail ID OF BIDDER along with tender documents.**
  26. **The bidder shall have to furnish present address along with Pin code, Active Mobile No. & Email Id. in separate sheet.**
  27. The bidder or agent authorized by him/her should remain present at the time of opening the technical bid
  28. Subsequent corrigendum/addendum if required shall only be available in web site indicated above.
  29. The Authority will not be held responsible for any technical snag or network failure during online bidding.
  30. Amendments made vide Works Dept. Memorandum No.12366 Dt 8.11.2013 will be followed scrupulously.
  31. General instructions to Contractor issued vide Lt No 20165/DOWR Dt 16.09.2015 will be adhered strictly.
  32. Scanned clear copies should be uploaded. Non-visible copies of Documents may be liable for rejection.
  33. No Extension of Time will be allowed. Penalty will be imposed as per Agreement Conditions if the work is not completed within the stipulated period / not in proportion to the work programme.
  34. The Tender will be opened on the next working day if the date of opening happens to be holiday.

36. If any intending bidders wish to withdraw from participation in the bid, He/ She can freely withdraw from the participation before scheduled date and time of closure, in case the 1st lowest bidder or even the next lowest bidder withdraw in series one by one, in later stage thereby facilitating a particular bidder for award, then they shall be penalized with adequate disincentives with forfeiture of EMD/ Bid security unless adequate justification for such back out is furnished. Appropriate action for blacklisting the bidder shall also be taken apart from disincentivizing the bidder.
37. GST on work contract as applicable at the time of payment shall be paid extra over the gross amount of running bill amount (vide section 15 & section 162 (ii) of Odisha Goods & Service tax Act 2017.




