4. The vehicle shall be kept under optimum running condition and avoid accidents attributable to lack up maintenance / upkeep.

7. Driver will be provided and paid by the owner.
8. Log Book to this effect will be maintained by this office.
9. Valid Registration and road/hiring permit certificate and the Driving License of the Driver, Insurance document and ownership certificate should be produced along with the quotation.
10. The undersigned does not bear any responsibility for any damage or mishap of the vehicle during the period of engagement.
11. Vehicle will be kept with the Driver/ Owner at his own risk.


