- 1. The interested suppliers/ firms should submit quotations in a sealed envelope super scribed with ".TENDER FOR SUPPLY OF METAL TRUNK FOR SGE, 2024, DISTRICT-NUAPADA". The sealed envelope containing the proposals must be delivered to the District Election Officer & Collector, Nuapada by speed post or in the drop box kept in District Election Office, Nuapada latest by 08.04.2024 (01.00 PM). Bids received after due date & Time will not be entertained and shall be liable for rejection.
- 2. The Security Money (EMD Cost) of Rs.10,000/- (Rupees Ten Thousand) only (refundable) and Tender application fee of Rs.500/- (Rupees Five hundred) only (non-refundable) are to be deposited in shape of Bank Draft drawn in favour of the OIC, Election, Collectorate, Nuapada payable at SBI Main Branch, Nuapada from any Nationalized Bank along with tender documents. Transfer or adjustment of E.M.D. will not be entertained. Shortfall of any required document, EMD and tender application fee will not be entertained and the tender paper will be liable for rejection.
 - 3. The Bidder must have valid GST Registration and PAN.
 - 4. The Bidder should have past experience in supply of Metal Trunk in last General Elections to Lok Sabha/OLA/Panchayat elections or any other similar service to any Govt. or Autonomous Body. Bidder must furnish proof in the form of purchase order.
 - 5. Evaluation will be done on the basis of rate quoted for Metal Trunk . L1 Bidder will be decided based on unit price of all items to be procured inclusive of GST & other taxes if any.
 - 6. No transportation charges will be claimed by the L1 bidder.
 - 7. Self attested Photocopy of valid PAN Card, GSTIN Registration Certificate must be enclosed by the bidder. The bidder must submit self attested copies of GSTIN Return/Income Tax Clearance (preceding 1 years) etc without which the Bid will not be taken into consideration.
 - 8. The bidder must provide quality service and timely performance in full as per the specification within the stipulated period at the places to be decided by the District Election Office, Nuapada.
 - 9. Any legal dispute arises out of this is subject to jurisdiction of Nuapada District only.
 - 10. The bidder should not have been blacklisted by any Govt organization. If found later on, action shall be taken against the firm as per the law. Affidavit must be submitted by the bidder in this regard.
