

- The tender documents consisting of plans, specifications, schedule of quantity and the set of terms & conditions of the contract will be made available for sale in the office of the **undersigned** to the contractors or to their authorized agents on payment of cost of tender paper (Non-refundable) in cash as mentioned at Col. No. 4 above.

The tender document must be accompanied with photo copies of valid Contractor's Registration Certificate (CRMS), valid ITCC (PAN Card), GSTIN registration Certificate, Bid Security Declaration. However, all the tenderers are required to furnish an affidavit duly sworn in before Executive Magistrate / Notary at the time of submission of tender papers about the authenticity of tender documents, falling which the tender will be rejected. Besides that, the tenderers also have sworn in the affidavit that, "I / We hereby confirm and declare that, if I / We will withdraw or modify the bid during the period of validity, I / We will be suspended for a period specified in the tender documents in the effect of **"Bid Security Declaration"**

4. **BID SECURITY / EARNEST MONEY DEPOSIT (EMD)** As per Office Memorandum No. 07554600032022- (Pt) 1499 /W, dated 01.02.2023 of Works Deptt. Govt. of Odisha Para 3.5.19 (a) (b) of the Odisha Public works deptt. code vol-I with the following modification "Security for the due fulfilment of a contract should invariably be taken. The Security may taken in shape of N.S.C.-Post office saving Bank account- Post office time deposit account- Kissan Bikas Patra - Bank Guarantee in favour of Block Development Officer, Panchayat Samiti Boden from any Nationalized scheduled Bank in India counter guaranteed by its local Branch at Bhubaneswar/ e-Bank Guarantee executed on Nationalized e - Governance Services Limited (NeSL) Digital Documents Execution Portal towards EMD / initial Security Deposit - any other Security deposit form the contractor or supplier". The above instructions will be applicable for all tenders issued.


5. The sale and receipt of tender paper will be available during office hour from **10.30 A.M. of dt.01.10.2024** up to **5.00 P.M. of dt 19.10.2024** & the same will be opened on date. **Dt 22.10.2024** at **11.00AM.** in the Office of the **under signed** in the presence of the tenderers or their authorized agents who wish to be present. If the Office happens to be closed on the date of receipt and opening of the tenders as specified, the same will be received and opened on the next working day at the same time and venue.

6. **Additional performance security in case of Abnormally Low Bids (ALBs)** Additional performance security shall be obtained from the bidder, when the bid amount is less than the estimated cost put to tender. In such an event, only the successful bidder who has quoted less bid price/rates than the estimated cost put to tender shall have to furnish in the following manner as per Office Memorandum No. 4559 dated 05.04.2021 of Works Dept. Govt. of Odisha.


7. The applicable Additional Performance Security (APS) shall have to be furnished by the successful bidder in shape of Term Deposit Receipt duly pledged in favour of the **Block Development Officer, Boden / Bank Guarantee** in favour of the **Block Development Officer, Boden** from any Nationalized/Scheduled Bank in India within seven days of issue of Letter of Acceptance (LoA) by the **Block Development Officer, Boden** to the successful bidder otherwise the bid of the successful bidder shall be cancelled and the EMD/Bid Security shall be forfeited. Further proceeding for blacklisting shall be initiated against the bidder. (As per Works Department Office Memorandum No.14459/W, Dated 20.09.2018).

8. Bid document can be purchased from Panchayat Samiti Boden . The bidders who want to purchased the bid document from the panchayat samiti Boden will have to pay the cost of the tender documents as indicated in column 4 (Four) of the above table in shape of demand draft drawn from any nationalized scheduled bank in favour of the **Block Development Officer Panchayat Samiti Boden**, payable at SBI Boden or Cash. Authority will not be held responsible, if any portion of the bid document is excluded or modified in the bid document.



Bids must be delivered in sealed cover super scribing the name of the work in the tender Box having mentioned as Tender Call Notice No. - 3823/DT 25/9/24 in the Office of the Panchayat Samiti, Boden. Bids shall be received in the Office of the undersigned by Registered post / Speed post only. The authority will not be held responsible for postal delay in the delivery of the documents or non-receipt of the same by 5.00 PM of date 19.10.2024.

10. In case of SC/ST bidder who wants to avail the price preference he must have to furnish the required affidavit to avail price preference.
11. The bid must be accompanied with the EMD / Bid Security as provided in the Bid document.
12. The Bidder must go through the Bid documents meticulously before dropping in the tender box.
13. Bid value should be exclusive of GST. GST on works Contract as applicable shall be paid at the time of Payment over and above the Gross amount of the Bill as per Odisha GST Act 2017.
14. The contractor has to quote the percentage excess or less up to two digits only after decimal point. If he quotes the percentage excess or less in more than two digits after decimal point, the first two digits after decimal point shall only be considered without rounding up.
15. In the eventually of failure on the part of lowest successful bidder to produce the original documents, he/she shall be debarred in future from participating in tender for three years and necessary action will be taken for black listing of contractor.
16. The Block Development Officer, Boden reserves the right to reject any or all the tender without assigning any reason thereof.


