PROCEEDINGS:

A meeting of the Tender Evaluation Committee, duly constituted with the kind approval of the Collector and DM, Nuapada was held on 18.10.2024 at 04.00 PM in the Office Chamber of the CDVO Nuapada for finalization of technical and financial bids of the tender for "ENGAGEMENT OF VEHICLE FOR O/O THE CDVO NUAPADA ON MONTHLY HIRING BASIS" issued vide Bid reference No 3465 Dt 24.09.2024. At the outset, the Chairman welcomed all the participants to the meeting and requested the ADVO(DC) to carry forward the meeting.

Then the ADVO(DC) informed the house that a tender for hiring of a vehicle for the O/o the CDVO, Nuapada was published in the District Website on 24.09.2024 vide bid reference no 3465 Dated 24.09.2024 and by the last date 4 bids have been received. Then the ADVO (DC) requested the house to examine the bids as per the terms and conditions laid down in the bid document.

Then the house opened and examined the technical bid documents and summarized its observation in Annexure I (General information) and Annexure II (MV documents). The MV documents were also counter verified from the M Paribahan portal and tallied with physical documents. Careful analysis of the comparative statement revealed that the bidder Biswa Bijayini Tripathy (Vehicle No OD 02 BM 0414) has submitted all the documents including GST and requisite fees. The other three bidders namely Tikelal Rout (Vehicle No OD 26 D 1222), Banamali Dehury (Vehicle No OD 05 BS 2739) and Saroj Kumar Tandi (Vehicle No OD 26 G 4986) had not submitted some documents asked for in the tender which is detailed in Annexure I. Since all the above vehicles of the all 4 bidders had valid MV documents verified physically and counter verified online from the M Paribahan Portal and the tender document did not have specific rejection criteria, the house unanimously decided all the 4 bids to qualify technical evaluation and decided to open the financial bids.

The financial bids were then opened and the house summarized its observations in a comparative statement of the financial bid in Annexure III. After a thorough discussion, the house decided to select L1 bidder on the basis of base price before GST. Careful examination of the comparative statement of the financial bid revealed that the Vehicle OD 02 BM 0414 belonging to the bidder Biswa Bijayini Tripathy, Old town, Bhubaneswar had the lowest quote of Rs 19,400.00. Since the same bidder had also submitted all general documents, MV documents and GST as requested in the bid document, the bidder Biswa Bijayini Tripathy with the vehicle No OD 02 BM 0414 was unanimously selected as the L1 bidder.


