1. Subject teacher engaged, would have no claim or right for appointment on a regular basis nor will they be a part of the cadre of teachers of SSD Department.
2. Working hours shall be of 3-4 hrs.
3. The engagement of these Subject teachers will automatically come to an end once the contractual period is over.
4. The performance of the Subject Teachers hired will reviewed on regular basis by the same committee and also an annual appraisal at the end of the academic year to allow further renewal. If any Subject Teacher is found to non-performing or engaged in activities leading to misconduct he/she shall be disengaged by the appropriate authority under intimation to the DWO.
5. The Subject Teacher engaged are directed to join within 7 days.
6. A subject teacher unauthorizedly remaining absent and not taking classes for a continuous period of 15 days or more deemed to be terminated and he/she shall never be entertained further.
