The **Superintending Engineer, Lower Indra Canal Division, Khariar, Dist- Nuapada (Odisha)**, on behalf of the Governor of Odisha invites **Percentage rate** bids for the works as detailed in table below from eligible contractors registered with the State Governments & Contractors of equivalent Grades / Class registered with Central Government / MES / Railways for execution of Civil Works on production of definite proof from the appropriate authority. The bidders may submit bid for the following works to be eventually drawn up in **P₁ Agreement Form**.

1. The tender documents consisting of plans, specifications, schedule of quantity and the set of terms & conditions of the contract will be made available for sale in the office of the **(i) Superintending Engineer, Lower Indra Canal Division, Khariar &** to the contractors or to their authorized agents on payment of cost of tender paper (Non-refundable) in cash as mentioned at Col. No. 4 above.

2. The tender document must be accompanied with photo copies of valid Contractor's Registration Certificate (CDMS), valid ITCC (PAN Card, GSTIN registration Certificate. However all the tenderers are required to furnish an affidavit duly sworn in before Executive Magistrate / Notary at the time of submission of tender papers about the authenticity of tender documents, failing which the tender will be rejected.

3. **Additional performance security in case of Abnormally Low Bids (ALBs)** Additional performance security shall be obtained from the bidder, when the bid amount is less than the estimated cost put to tender. In such an event, only the successful bidder who has quoted less bid price/rates than the estimated cost put to tender shall have to furnish in the following manner as per Office Memorandum No. 4559 dated 05.04.2021 of Works Dept. Govt. of Odisha.

4. The sale of tender paper will be made during office hour from **10.00 A.M. of dt.13.12.2024** up to **11.30 A.M. of dt.19.12.2024**. Bid documents completed in all respect will be received by **Registered Post/Speed Post Only** i.e up to **22.12.2024** up to **4.00PM** & the same will be opened on date. **dt.23.12.2024** at **11.00 A.M.** in the Office of the **Superintending Engineer, Lower Indra Canal Division, Khariar, Dist- Nuapada (Odisha)**, in the presence of the tenderers or their authorized agents who wish to be present. If the Office happens to be closed on the date of receipt and opening of the tenders as specified, the same will be received and opened on the next working day at the same time and same venue.

5. Registration in the Contractors Data Base Management System (CDMS) by the bidder is mandatory, the bidders who have not registered in CDMS, his / her bid shall be declared as non-responsive and thus liable for rejection.

6. The applicable Additional Performance Security (APS) shall have to be furnished by the successful bidder in shape of Term Deposit Receipt pledged in favour of in favour of the **Superintending Engineer, Lower Indra Canal Division, Khariar** within seven days from the date of finalization of tender otherwise the bid shall be cancelled and the security deposit shall be forfeited. Further, proceeding for blacklisting shall be initiated against bidder. (Vide Office Memorandum No -14459/W dated 20.09.2018 of Works Department, Govt. of Odisha). In case of SC/ST bidder who wants to avail the price preference he must have to furnish the required affidavit to avail price preference.

7. The single tender received in the 1st tender call shall be cancelled without opening of the bid. The acceptance of a single tender received even after re-tendering should have prior approval of next higher authority.

8. If the rate quoted by the bidder is less than 15% of the tender amount then such a bid shall be rejected and the tender shall be finalized basing on the merit of rest bids. But if more than one bid is quoted at the same percentage of (Decimal up to two nos. will be taken for all practical purpose without rounding up) less than the estimated cost the tender inviting authority will finalize the tender through a **transparent lottery system**. The transparent lottery will be held in the office chamber of the **Superintending Engineer, Lower Indra Canal Division, Khariar** on **dt.24.12.2024 at 12.30 P.M** if required.

9. The bid validity is **90 (Ninety)** days from the last date of receipt of bids. If any bidder / tenderer withdraw his bid / tender before the said period or make any modification in terms and conditions of the bid.

10. The Bidder must go through the Bid documents meticulously before delivering in the Post Office.
11. Bid value should be exclusive of GST. GST on works Contract as applicable shall be paid at the time of Payment over and above the Gross amount of the Bill as per Odisha GST Act 2017.

12. In the eventually of failure on the part of lowest successful bidder to produce the original documents, he/she shall be debarred in future from participating in tender for three years and necessary action will be taken for black listing of contractor.

13. The Superintending Engineer, L.I. Canal Division, Khariar reserves the right to reject any or all the tenders without assigning any reason thereof.
